Good evening Mayor & Council,

Although the subcommittee did not recommend me for an appointment to the Advisory Commission at this time, I appreciate the opportunity to have applied for this role. I wish only the best for the appointees and look forward to engaging with them as a member of the community to improve the transportation accessibility in our city.

I really encourage the Council and the Commission to look at how we can incentivize our residents and visitors to get out of their cars. If we want to see a reduction in traffic, building and expanding our roads cannot be the only solutions. Bikes offer an amazing opportunity for us to travel without a car. However, we have many disconnected bike paths that make it difficult and sometimes dangerous for riders. Improving bike access and paths will aid in improving traffic flow, physical health, and air quality.

I also encourage how we can prioritize Tracer and make sure that new neighborhoods and developments are better integrated with our public transportation. I remember speaking with community members who would love to take Tracer, but cannot because the routes don't make sense to them and do not come frequently enough to warrant its use.

If we're serious about reducing traffic and emissions, then we need to transition from a car-centric model of planning and figure out new, reliable, and invigorating ways to spur people to rethink how they travel and how they may enjoy doing so.
