I am writing this in response to the City's public outreach regarding the Westside Specific Plan. I attended the meeting in person on July 22nd. It was somewhat discouraging to see the LACK of city residents. The City may want to rethink how it currently does public outreach. Please add this to what is already in tonight's agenda packet, if possible.

Why doesn't Tracy look at the Westside project as an opportunity to emerge as a city of innovation for San Joaquin County? Consider the impacts that green buildings and sustainable communities would have on the area, especially when looking at AB 32, California's Bill to reduce GHG emissions. Reductions in GHG will come from virtually all sectors of the economy and will be accomplished from a combination of policies, planning, direct regulations, market approaches, incentives and voluntary efforts. Building warehouses that put more trucks on the road will hardly help in the state's mission to reduce GHG and in fact, the transportation sector remains the largest source of GHG emissions in the state accounting for 40%^{*} of statewide emissions(*CARB report as of July 28, 2021).

Please don't build anymore warehouses or approve warehouses for that site. There is plenty on the books already. Listen to the residents, the ones who voted for you. It's time for Tracy to end it's warehouse phase and begin it's much needed and wanted commercial phase.

I have included some images that I hope will ignite your imagination of what Tracy could become and will hopefully, in the least, start the conversation.
