Commissioners discussed and preferred this more simplified outline across 5 slides. With confirmation of the artists acknowledgements, CAS Wilson will provide contact information to Vice Chair Reis, so that she may network with them.

4. DISCUSSION OF 2021-22 BUDGET AND PROGRAMMING

CAS Wilson provided the Staff Report and advised the Downtown Street Banner Project was estimated at \$1,300, working with four artists to create four double-sided banners. As the TAC budget is currently only \$2,114, he advised Staff would look to supplementing project funding from elsewhere in the Division budget if needed.

Commissioners inquired how to restore funding that was cut over the past two years due to COVID-19. CAS Wilson advised a 2021-22 Budget Augmentation Form could be submitted for mid-year adjustment consideration. Commissioners agreed the augmentation (\$8,386) should be enough to return the TAC budget to the pre-pandemic level of funding, to total \$10,500.

Commissioners estimated \$2,000 for Artsweek/month, \$1,800 for the June Artwalk including a new emerging artists presentation, \$1,600 for the Downtown Banners as a

Pilot Project, \$4,000 for the Granting Program, and \$1,100 for Civic Art and project contingency.

Commissioner Sandhu suggested a return to more visible multicultural programming, in the form of a performance at the Grand with ethic groups in the community. Commissioners continued discussion suggesting and considering an outdoor event, downtown or park venue, a large event or a small event series, and using the existing platforms of Artsweek/month and the Artwalk. With general support of creating new multicultural programming, Chair Dhugga requested a meeting of the Special Events Subcommittee on Tuesday, October 5 at 6 pm in order to create recommendations.

Vice Chair Reis suggested a new visual and literary arts publication. Commissioners voiced interest but would like more details. VC Reis agreed to bring this idea back to the discussion at a later time, with additional production information for the Commission's consideration.

REQUEST

CONTINUE DISCUSSION OF FY2021-22 BUDGET AND PROGRAMMING

DISCUSSION

The Tracy Arts Commission (TAC) budget resides in administrative accounts of the Cultural Arts Division (CAD) budget. The TAC FY21-22 budget is \$2,114, the same level of funding in FY20-21. The TAC has requested Staff to submit a mid-year budget augmentation of \$8,386. If approved, this would restore TAC funding to the pre-COVID 19 level of \$10,500.

The TAC meets annually to discuss funding and programming in effort to best meet goals. Through this dialogue recommendations are formed. It is anticipated that budget and programming recommendations can be reviewed and approved at the meeting of November 9.
