


# Valley Link EIR Alignment, SJCOG I-205 Managed Lanes Fixed Guideway Concept






#### **CEQA Final EIR Preferred Alternative**




# San Joaquin Council of Governments I-205 Managed Lanes Project, Fixed Guideway Concept Alignment. PA&ED Phase.








#### Valley Link Final EIR Altamont Section



## TRACY MUNICIPAL CODE

- 5.08.210 Definitions.
- (a) Wherever the word "animals" is used herein, it shall be construed to include horses, ponies, mules, jacks, jennies, cows, bulls, calves, heifers, sheep, goats, swine, rabbits and all other domestic or domesticated animals other than household pets.
- (b) "Poultry" shall be construed to include pigeons, chickens, ducks, geese, turkeys, and all other domestic or domesticated fowls other than household pets.
- (c) "Household pets" shall be construed to include cats, dogs, canaries, parrots and other kindred animals and birds usually and ordinarily kept as household pets.
- (d) "Dwelling" shall be construed to mean the main or principal dwelling located on the property of a person other than the keeper of the animals or poultry.

# VEGETATION

## MIGRATORY BIRD TREAT ACT 1918

A federal law that was first enacted in 1918 to protect migratory birds between the United States and Canada. It is unlawful without a waiver to pursue, hunt, take, capture, kill, or sell nearly 1,100 species of birds listed therein as a migratory bird.

- (1) Assisting with continued education by Animal Services to the impacted community about using deterrent measures;
- (2) Assisting the Redbridge Homeowner's Association with partial funding and hiring a wildlife trapper to remove the peafowl from the area; or
- (3) Refrain from taking action.
