Brad Albom, owner of Great Plate spoke about the City demolishing the building, repairs made to the building, and stated the building is now safe. Mr. Albom shared his concerns with staff regarding inspections of the property, and requested Council reconsider their decision to demolish the building.

Mayor Pro Tem Vargas stated the City has been trying to bring the building up to code since 2018, multiple hearings have occurred. There is a judgement from a San Joaquin Judge authorizing the City to do this for public safety, and additional time was allowed to avoid demolishing.

Nancy Ashjian, Assistant City Attorney confirmed it is a stipulated judgement and the City has been working the Great Plate for a number of years to get the building up to code.

Mayor Young unsuspended Item 4 and recessed to closed session at 6:44 p.m.
