DISCUSS REVISION OF CIVIC ART PLAN

DISCUSSION

City Council adopted the Civic Art Plan (Reso 2003.002 100703) in 2003, designed as a five-year roadmap to establish a program, provide guidelines, and set goals. The Civic Art Program (CAP) has functioned and evolved across the past 18 years, most significantly with the formation of the Cultural Arts Division and the Grand Theatre Center for the Arts in 2007. The CAP is in need of an updated plan in order to streamline City operations, and effectively serve a larger and more diverse community.

Cultural Arts Division Staff and the Tracy Art Commission have been working to create a contemporary revision of the Civic Art Plan to better define purpose and value, address challenges, and document accomplishments. The revision will provide funding recommendations, updated guidelines, new goals, and a chronology of milestones.

The Civic Art Subcommittee (CAS) and Staff will continue discussion in order to bring an updated version of the CAP to the Tracy Arts Commission for review and approval in 2022. With TAC approval, the CAP can be recommended for future City Council review and adoption.
