TRACY ARTS COMMISSION – CIVIC ART SUBCOMMITTEE SPECIAL MEETING MINUTES December 14, 2021, 6:00 p.m.

1. ITEMS FROM THE AUDIENCE

2. DISCUSS REVISION OF THE CIVIC ART PLAN

CAS Wilson provided the Staff Report and reviewed edits made to the Index, Executive Summary, Overview of the Planning Process, and Civic Art Plan Recommendations. Discussion of Funding Strategies included defining eligible Capital Improvement Projects (CIP) and budgets for civic art projects.

Commissioners agreed to recommend a minimum of 1% of total qualifying project budget should be allocated in order to properly fund and grow the Civic Art Program. This allocation could be itemized in the project budget or from the project budget's contingency, and be documented and considered in the CIP planning process. Continued discussion is needed to determine minimum budgets that would result in meaningful project components.

Commissioners agreed additional funding from private development fees and/or contributions from the City's transient occupancy tax (TOT) should also be considered for program growth and sustainability. These fees would contribute to a Civic Art Fund, which could then be used to develop new projects and maintain existing assets.

CAS Wilson advised he will continue to update the working draft as needed for each meeting. The CAS is scheduled to meet again on Tuesday, March 8 at 6:00 pm.

CAS Wilson provided the Staff Report. Commissioners continued discussion of ideas for new multicultural programming, with a focus on how to determine who should be invited to be presented. CAS Wilson suggested reviewing recent U.S. Census data in order to review the demographics of the City, as well as communicating directly with community groups to better understand their needs or how to best support them.

Commissioners agreed the best approach would be one of broad arts and culture recognition, where the community-at-large could share a cultural experience, rather than presenting a specific performance or event already with established, related audiences. Commissioners Dhugga, Lees, and Reis continued to support the incorporation of new multicultural programming within the existing Cultural Arts Division platforms of Downtown Tracy Arts Month and Artwalk which have diverse audiences, and felt the Grand Theatre Center for the Arts is the best venue. Commission Sandhu disagreed and felt another, larger event should be created instead.

Commissioners agreed to contact cultural organizations in and near Tracy that they are aware of, and bring feedback for continued discussion at the meeting on January 11, 2022.

5. REVIEW AND APPROVE FY2021-22 BUDGET AND PROGRAMMING RECOMMENDATIONS

CAS Wilson provided the Staff Report and advised the City Council approved a budget augmentation of \$9,000, resulting in a total FY21-22 Tracy Arts Commission budget of \$11,114. As a result, the expenditures for project contingency and the Civic Art Program were amended from \$1,100 to \$1,714.
