NOTICE OF COUNCIL-APPOINTED BOARD VACANCY

COMMISSION/BOARD: **Board of Appeals**

NUMBER OF VACANCIES: Two (2), (one engineer and one contractor)

POWERS AND DUTIES: As set forth in the Tracy Municipal Code Chapter 9.44

PURPOSE: To hear appeals of administrative decisions regarding use of alternate materials, interpretations pertaining to enforcement of any provisions of the Building, Plumbing, Mechanical, Electrical, Fire Codes and related regulations listed in TMC Section 9.44.010.

To hear appeals of administrative decisions on the application of the Uniform Housing Code, the Uniform Code for the Abatement of Dangerous Buildings, and related sections of this Code in actions declaring certain structures or conditions therein substandard, unsanitary, or hazardous and requiring their consideration, rehabilitation, reconstruction, correction, or abatement as applicable. The Board will also serve as the appeal board when determinations are made regarding special conditions for person with disabilities.

Following the hearing, the Board shall formally report, in writing, its findings of fact, and together with the reasons, its decision, to be forwarded to the petitioner and to the administrative office whose decision has been appealed.

QUALIFICATIONS: The Building Board of Appeals shall consist of five (5) members appointed by the Mayor with advice and consent of the Council. The Board shall consist of members who are qualified by experience and training to pass on matters pertaining to building construction (such as licensed contractors, engineers and architects).

The term of office for each member shall be four (4) years with staggered terms. Vacancies occurring during a term shall be filled for the unexpired period of such term. Members shall serve at the pleasure of the Council and may be removed from office without cause upon an affirmative vote of the majority of the Council. A member shall be neither an elected officer nor an employee of the City, but may be a member of another City board or commission. A member need not be a resident of the City.
