COMMISSION/BOARD: **Planning Commission**

NUMBER OF VACANCIES: Three (3)

POWERS AND DUTIES: As set forth in the statutes of the State of California and in the Municipal Code of the City of Tracy.

Meetings - Planning Commission regular meeting, 2nd and 4th Wednesday of each month. In addition, adjourned, special or workshop sessions may be scheduled. Compensation: \$50.00 per meeting, not to exceed \$150 per month.

Prepare and recommend adoption, amendment or repeal of the City's long term General Plan, or portion thereof.

Advise and recommend - to the proper City officials regarding: maps or plats of land in accordance with Subdivision Map Act of the State and City Code.

Hold hearings on planning and zoning matters per State and City laws.

Advise and recommend regarding acquisition, use, or disposition of City-owned property.

QUALIFICATIONS: Planning Commission members shall be citizens, not City officials or employees of the City and **shall live within the City limits.**

Members shall serve at the pleasure of the Council and may be terminated at any time by a majority vote of the entire Council and are entitled to hearing process per Municipal Code regulations.

If a member of the Planning Commission fails to attend four (4) consecutive regular meetings or adjourned meeting, and is unexcused for those absences, his/her position on the Commission shall automatically become vacant.

Members appointed for four (4) year terms, except in the case of unexpired portions of term, which shall be filled by appointment for the unexpired portion of such term.
