Mitchell Harnett introduced himself and handed out packets that Tracy Bike Life put together for the commission and staff. He has been in the City of Tracy for 8 months and is excited to be a part of the cycling community here. He sees so much opportunity and potential for the riders if the City would follow through with safe riding opportunities for them. He will comment again when it is time for commenting on item 6b.

Garret Murphy commented that in addition to seeking a pump track, Tracy Bike Life is partnering with the Tracy Earth Program and Tracy Police Department for the Tracy Youth Bike Program. This program allows kids learn how to work on their bikes and fix them. Tracy Police Department is donating the unclaimed bikes for the group to work on and repair.

Mitchell Harnett with Tracy Bike Life stated that this is his first time doing anything like this and he wants to make sure his passion comes through.

Mr. Mitchell made the following statements:

- 1. This is something he is very committed to and is amazed by the commitment and drive some of the kids have by coming the commission meeting for the chance to get a bike facility. 2.
- 2. He is an avid cyclist and competes in the Summer. He has used pump tracks all throughout the Bay Area to help condition and ride in a safe environment. Additionally, he serves as a board member for the Kids Bike Lane, a charity out of the Tri-Valley, helping underserved families get access to bikes and empowering the youth the get out there and enjoy spending time on two wheels. He stated he also sells bikes online.
- 3. He tries to participate in all aspects of the cycling world. Now he is doing his civil duty by speaking up for the cycling community. He wants to make a point to the staff and commission that they will be blown away with how much a pump track will be used and loved by kids and families of all ages. It has made an impact on his life. He understands how important it is to diversify parks and he couldn't agree more. Some things he has noticed biking around Tracy is that there is a lot of empty grass and it feels like there is opportunity to utilize the grass space. He stated we are still in a drought and could create a paved pump track or bike course.
- 4. He is in contact with a contractor who builds bikes in the Bay Area and he also helped build the course for the Rio Olympics BMX course. He's a very nice, very intelligent guy.
- 5. He has competed on his courses and he can stand by his work. He stated the contractors ball parked for a half-acre, paved pump track is no more than \$100,000 and they are just asking to have some place to ride safely.
- 6. Stated that the bike life group are improving their heath and spending time as a second community, not creating any traffic issues.
- 7. It really stresses him out to see the kids in the street and wants to prevent that as much as possible because that is when accidents happen. Something else he wanted to ask was where are the results of the November Community Input Survey that he participated in. He asked where that can be seen.
- 8. He will continue to show up at Commission meetings to ask questions and show his support.

Jolene, Recreation Manager, answered his question.

Commissioners commented and thanked him for his information packet, support, and passion.

## REVIEW AND ACCEPTANCE OF THE PARKS AND COMMUNITY SERVICES COMMISSION'S SUBCOMMITTEE RANKING AND FUNDING RECOMMENDATIONS FOR THE ALLOCATION OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS AND HOME INVESTMENT PARTNERSHIPS PROGRAM (HOME) FUNDS FOR FISCAL YEAR 2022-2023 AND RECOMMEND APPROVAL TO CITY COUNCIL

## **DISCUSSION**

Community Development Block Grant (CDBG) and HOME Investment Partnerships Program (HOME) funds are allocated to cities and counties by the United States Department of Housing and Urban Development (HUD) for use in projects that make for a viable community, with local programs and services that provide decent housing, a suitable living environment, and expand economic opportunities for low- and moderateincome individuals and families. The City of Tracy receives an annual pass-through allocation from San Joaquin County, which serves as the entitlement community. There is no impact to the City General Fund.

On November 15, 2016, the City Council adopted the Parks and Community Services recommendation for local funding priorities, to be considered in this allocation process in priority rank order:

## <u>CDBG</u>

Public Services Category:

- (1) Food Distribution Services
- (2) Homelessness Prevention, Intervention and Transitional Housing Services
- (3) Senior and Special Needs Services
- (4) Domestic Violence Services
- (5) Youth Education and Enrichment Services

Public Facilities/Improvements Category:

- (1) Public Parks and Facilities
- (2) Removal of Architectural Barriers (ADA)

**HOME** 

~~~~

- (1) Address issues of public safety, health and welfare;
- (2) Rehabilitate residential properties occupied by low-income persons; and,
- (3) Partner to construct income restricted family and senior housing facilities.

San Joaquin County has provided estimated amounts of CDBG and HOME funds to be allocated to the City of Tracy in the FY 2022-2023 program year as follows:

The County requires ranking of the applications among each eligible CDBG/HOME local funding category, and a minimum allocation of \$5,000 for CDBG Public Service awards and \$150,000 for CDBG Public Improvement/Public Facilities awards. Ranking of applications among each local funding category allows San Joaquin County, as the entitlement community, to potentially allocate any supplemental CDBG/HOME program funds to the highest ranked local priority services and projects.

The Parks and Community Services Commission CDBG/HOME funding allocation recommendations will go before the Tracy City Council on March 15, 2022. The San Joaquin County Board of Supervisors are scheduled to review and consider all local funded projects in May 2022 and submit those recommendations to the U.S. Department of Housing and Urban Development (HUD) for final approval.

## **Subcommittee Review and Recommendation:**

CDBG/HOME grant applications for FY 2022-2023 were available beginning December 6, 2021, with a submittal deadline of January 20, 2022. On December 6, 2018, the Parks and Community Services Commission discussed and adopted a funding allocation formula for CDBG Public Service grant applications. The adopted funding allocation formula is as follows:

- The top two scoring public service program applications will be funded the requested amount up to a max of \$12,000 each.
- Applications ranked 3 and 4 will be funded the requested amount up to a maximum allocation of \$8,000 each.
- Applications ranked 5 and below will receive a \$5,000 allocation in order of applicant ranking until funds are exhausted.
- Any remaining funds less than \$5,000 will be distributed to applicants 5 and below until exhausted, so long as it does not exceed Tier 2 max amounts and their funding request.

The Parks and Community Services Commission Subcommittee consisting of two (2) Parks Commissioners and one (1) internal City staff member reviewed each application and scored them electronically using the City's eCivis Grant Management Portal based on local funding priorities and project details between January 20, 2022 and January 26, 2022. Two (2) Members of the sub-committee met virtually on January 26, 2022 to discuss the applications and finalize their recommended funding allocations to the Parks and Community Services Commission. Staff met with the third sub-committee member by phone on January 27, 2022 to discuss the applications and communicate the funding allocation recommended by the other two sub-committee members, to which the third member communicated their support of the recommendations.

Individual scores for each application were averaged to determine a final score. In the case where two applications received the same score, priority was given to the applicant whose local funding priority ranked higher. In the case where both applicants with the same score met the same local funding priority, the sub-committee came to consensus and broke the tie. The Subcommittee recommendations for application ranking and grant funding allocations for FY 2022-2023 are listed in Attachment A. All CDBG/HOME program funding is subject to final confirmation by San Joaquin County and HUD.
