#### **CONTINUE DISCUSSION OF 2022 GRANTING PROGRAM**

#### DISCUSSION

As part of the Tracy Arts Commission's (TAC) on-going efforts to offer new and relevant programming in the community, and provide resources to the creative community, a new Granting Program (GP) has been designed.

In March of 2019 the TAC approved the Budget Subcommittee's funding recommendations for FY2019-20 in the amount of \$4,000; three grants at \$1,000 each and four mini-grants at \$250 each. Public surveys collected at the Downtown Tracy Artwalk events in 2019 also identified support for grants at modest amounts up to \$1,000. Staff has created new GP guidelines and an application that are less complicated and more user friendly as the TAC recommended.

On behalf of the City of Tracy, the TAC is inviting applications from Tracy-based artists of all kinds, arts educators, and arts organizations wanting to develop and presents arts and cultural-based projects in Tracy. Projects will be accessible to the public in the form of events and activities such as classes, exhibits, festivals, performances, etc. The GP seeks to strengthen resources available to the creative community, encourage and support collaborative projects, promote arts education while serving diverse audiences, and increase public access to the arts. Grantees will be required to submit a final report to help the TAC evaluate the outcomes of supported projects.

Executive review of the guidelines and application copy were completed in December, 2021. The TAC reviewed and approved 2022 Granting Program Request of Proposals at the meeting of March 8. The Request For Proposals is in distribution, and as orientation workshop was held on March 30. Applications are due by 5:00 p.m. on Monday, May 2. Discussion in support of this programming will continue as needed, and proposals are scheduled for review and recommendation at the meeting of May 10.

# REVIEW AND APPROVE PUBLIC/PRIVATE MURAL PROJECT SUPPORT FOR BYRON ALVAREZ PROPERTY REQUEST FOR PROPOSALS AND PROJECT RECOMMENDATIONS

#### DISCUSSION

Within the functions of the Civic Art Program, the Tracy Arts Commission (TAC) and Cultural Arts Division (CAD) Staff serve a resource to the community-at-large. Periodically the TAC and Staff are approached by business and property owners who are interested in developing or hosting Civic Art projects at their locations. These public/private collaborations are unique, ranging from simple consultations to assisting in fully developed projects, each with their own goals, scale, and budgets.

In January of 2022, Mr. Byron Alvarez requested support for a new mural project at his property located at 27 W. 10<sup>th</sup> St., Tracy, CA. This project will replace an existing mural on the eastern, parking lot wall of Town & Country. Mr. Alvarez requested the Tracy Arts Commission to issue a Request For Proposals (RFP) to help identify interested artists. In addition, the TAC is requested to review the proposals and provide recommendations to Mr. Alvarez for his consideration. All other components of the project including artist selection, negotiation, contract, project development, schedule, etc. remain under the control and direction of Mr. Alvarez as the property owner.

The Civic Art Subcommittee (CAS) and Staff met on March 8 to discuss the project's specification and goals, in order to create an RFP. Recommendations before the TAC are to:

- Provide the requested project support by issuing an RFP, and reviewing and recommending proposals for the property owner's use and reference.
- CAS Subcommittee to form a project team with a member of West Side Pioneer Association Tracy Historical Museum.
- Project Team to review proposals and form recommendations in July, to be provided to Mr. Alavarez.

Cultural Arts Division Staff would remain in contact with Mr. Alvarez to provide project updates when available.

# 27 W. 10<sup>th</sup> St. Mural Project Support Request For Proposals

# **Project Intent**

The City of Tracy – Cultural Arts Division & Tracy Arts Commission is collaborating with Mr. Byron Alvarez in support of the creation of a new mural project located at 27 W. 10<sup>th</sup> St. in downtown Tracy, California. This high-visibility site is the east wall in the parking lot of Town and Country restaurant.



This project seeks to create a large-format painted mural, approximately 100' long x 14' high. The mural is considered to be a temporary project with a five-year lifespan.

Works in acrylic, latex, and aerosol paint media will be considered. Artists may submit up to three concepts in their proposals.

To assist artists the following considerations have been identified as important to the success of the project:

- Welsh heritage of the Alvarez family. Incorporating Welsh culture & tradition such as the flag, traditional dress, famous landmarks, etc.
- Tracy's agricultural, industrial, transportation, travel, and/or food history

 Open to other attractive images and themes that add interest and beauty to the downtown location

Artists are encouraged to make a site visit to better understand the details and environment of the project.

# **Budget**

The projected total budget for this project is estimated at \$2,500 – \$3,000, with terms negotiated between property owner and artist.

# **Eligibility**

This project is open to all artists in the Civic Art Program pool and any artist(s) that have requested to be considered for projects, as well as the creative community-at-large. Creative teams are eligible to apply as long as one member of the team is designated as the Lead-Artist.

The City of Tracy and the property owner reserves the right to change the project timeline as needed.

#### **Proposal Content & Review Process**

Artists interested in this project must prepare and submit the following materials:

- 1. Statement of Intent
  No more than one page in length, explaining interest and concept of the project.
- 2. Current Resume(s) or Bio(s)
  If submitting as a team, a current resume or bio of all members should be provided. Lead Artist's resume or bio must include complete contact information.

### 3. Conceptual Artwork

Artists should prepare conceptual illustrations or images representative of the final artwork they would develop. Conceptual artwork must be no smaller than 8" x 10" and no larger than 11" x 17" in size.

### 4. Support Materials.

Artists should submit any support materials representative of similar work/projects that may be applicable to the consideration and review of the proposal.

Proposals should not be bound or stapled, as they will be duplicated for review. Proposals should be placed in an envelope and labeled with the project title.

The Civic Art Program Subcommittee/Project Team (including West Side Pioneer Association – Tracy Historical Museum representative) is responsible for initial review of all proposals. The Subcommittee/Project Team will make recommendations for this project to the property owner. All other components of the project including artist selection, negotiation, contract, project development, schedule, etc. remain under the control and direction of the property owner.

While the design concepts submitted for this RFP and the original artworks remain the in ownership of the artist, all submitted materials will become the property of the City of Tracy and may be shared with the property owner. Images of the concept designs and final artworks may be used in publicity for the City of Tracy. All of the submitted materials are public records subject to the California Public Records Act. Submission of proposal(s) constitutes the acceptance of these terms.
