REVIEW AND RECOMMEND PROPOSALS FOR 27 W. 10TH ST. MURAL PROJECT FOR BYRON ALVAREZ PROPERTY

DISCUSSION

Within the functions of the Civic Art Program, the Tracy Arts Commission (TAC) and Cultural Arts Division (CAD) Staff serve a resource to the community-at-large. Periodically the TAC and Staff are approached by business and property owners who are interested in developing or hosting Civic Art projects at their locations. These public/private collaborations are unique, ranging from simple consultations to assisting in fully developed projects, each with their own goals, scale, and budgets.

In January of 2022, Byron Alvarez requested support for a new mural project at his property located at 27 W. 10th St., Tracy, CA to replace an existing mural on the eastern, parking lot wall of Town & Country. At the Civic Art Subcommittee (CAS) special meeting of March 8 agreed to provide project support as requested, and provided feedback for the creation of a Request for Proposals (RFP). The Cultural Arts Division, on behalf of the Tracy Arts Commission and with Mr. Alvarez's approval, issued an RFP in May to help identify interested artists. Proposals had a receipt deadline of 5:00 pm on Thursday, June 30.

The CAS will review eligible proposals and provide recommendations for Staff to provide to Mr. Alvarez for his consideration. All other components of the project including artist selection, negotiation, contract, project development, schedule, etc. remain under the control and direction of Mr. Alvarez as the property owner.
