Scooter tour highlights sidewalk problems

Dan Schack guided a motorized scooter down the sidewalk as he followed Liz Jackson's route along 11th Street late Tuesday afternoon.

He stopped near a crosswalk at Tracy Boulevard to check his notes as he joined a senior advoacy group looking for trouble spots on Tracy streets for people who travel on four wheels nstead of two feet.

"It's given me an opportunity o see things from a different perspective," Schack said. We can't visualize it until we re sitting in their seat. The genral public doesn't have any idea of what they face without being a their shoes."

Schack, the president of he Tracy Friends for Parks, lecreation and Community lervices Foundation, joined nembers of the Tracy Senior dvocacy that took part in the idewalk check to find hazards or people who use scooters and ther mobility devices.

Jackson, who has used a cooter to travel around Tracy nce 2001, said that uneven avement edges at the ramp at 10 southwest corner of Ninth 11 d B streets near the Tracy 12 st office, and similar problems sewhere, created concerns for 12 and other scooter users.

"I was afraid I would fall over tekwards," Jackson said. "They ake me go into the street, and know they don't want us to go to the street." The Tracy Senior Advocacy Association, formed in January 2013, promotes safety and health for older adults, provides resources and advocates issues important to them.

The president of the association, Brent Riddle, who works at Reich's Medical Supply, said the topic of unsafe streets and sidewalks had been mentioned several times, including by customers who rented scooters at the store.

Cracked sidewalks and unusable ramps, among other problems, were brought to the association's attention.

To test the streets and sidewalks firsthand, Riddle gathered several association members downtown with scooters on Tuesday. Riddle also planned to let members of the association check out scooters for a week at a time to check their neighborhoods.

"We want to identify and prioritize the problem areas, like the post office," Riddle said. "We realize the city can't fix them all, but we need to work on corners that are used the most."

Six people fanned out from Ninth and B streets, taking different paths that might be frequented by seniors on scooters. The riders traveled routes about one to two miles from downtown.

Destinations included Lolly Hansen Senior Center, doctors' offices, shopping centers and Sutter Tracy Community Hospital. Riddle rode a scooter from downtown to the hospital and said he gained a view of what people who use scooters regularly have to deal with.

"It was a good start. Everyone found one or two trouble spots," Riddle said. "It was good to see things they come across from their perspective."

Each person with a scooter checked the sidewalk corridor — the part of the walkway from the edge of the road to the property line along side streets between street corners.

They were looking for narrow pathways, obstacles in the sidewalk, severe grades and slopes, uneven surfaces and protruding edges of ramps and roadways near crosswalks.

With a few blocks behind him, Schack said he had already found a misaligned crosswalk at 11th and B streets, cracked utility covers that caught at his scooter's wheels and a driveway obscured by bushes — a potential safety hazard.

"One of the purposes of this exercise is to identify existing obstacles residents face," Schack said. "Unless they are pointed out as an obstacle or problem, we don't know about it."



Memorial Day service set for Monday

The sacrifices made by men and women in the U.S. Arried Service's will be remembered in Memorial Day ceremonies Methoday.

Ceremonies begin at 10 a.m. a. Tracy Cemetery, 50. E. Schulte Road, with a proclavation present ed by the city. The guest speaker will be Bob Elliott, mairman of the San Joaquin County Board of Supervisors.

Elliott, a former Trucy city councilman, retired as a columel in the U.S. Army Special Forces, having served 30 years. He served as deputy commander of the 1st Special Warfare Training Group, as commander of the 4th Special Operations Support Command and at the U.S. Embassies in Japan and Korea.

New to this year's ceremony will be Bruce Haugland singing "Not Just Once a Year." Tracy Community the Unknown Veteran grave, followed by the firing of three volleys. The playing of taps will end the ceremony at the cemetery, which will be led by John Treantos.

A short service at the Tracy War Memorial in Tracy Civic Center will follow 45 minutes later, including the roll call of honored dead will be read out loud and placement of a wreath.

Refreshments will be served afterward at the American Legion Hall, 1960 N. Tracy Blvd. sponsored by the American Legion Auxiliary.

Memorial Day ceremonies are organized by members of American Legion Post 172 and Veterans of Foreign Wars Post 1537.

The Tracy Cemetery will have flags placed at veterans' graves Saturday by local Scout groups.

The Tracy Memorial Day observance has take place for more than 30 years.
