#### **RECOMMENDATION**

# Staff recommends that City Council ratify the proclamation confirming the existence of a local emergency related to the severe winter storm.

#### EXECUTIVE SUMMARY

On January 4, 2023, the Director of Emergency Services, under the authority granted by the Tracy Municipal Code section 3.24.050, proclaimed a local emergency related to a significant winter storm that affected the City of Tracy. Additionally, on the same day, Governor Newsom declared a state of emergency for the whole state as a response to the calamity caused by the storm system sweeping California.

As required by state law, City Council must ratify the proclamation declared by the Director of Emergency Services, for the local emergency to continue for an excess of seven (7) days. As the National Weather Service has reported, there is the anticipation of heavy rain and winds for the next ten (10) days, which may continue to cause destruction throughout the City.

#### **ANALYSIS**

On January 4, 2023, Governor Newsom proclaimed a state of emergency for the severe winter storm affecting Northern California, bringing high winds, and substantial precipitation with river and urban flooding plaguing the area.

Under Tracy Municipal Code section 3.24.050, the City Manager (as the Director of Emergency Services) is authorized to proclaim the existence or threatened existence of a location emergency when the City is affected or likely to be affected by a public calamity while City Council is not in session. The California Government Code section 8630, subsection (b) states that when an emergency proclamation is made by an official designee (the Director of the Emergency Services), the governing body needs to ratify the proclamation for the state of emergency to continue in excess of seven (7) days.

The National Weather Service has reported that this storm is slated to last at least ten (10) days, following a storm that has already water-logged the City. The previous storm, from the weekend prior, has resulted in flooding and fallen trees all throughout the area, endangering residents and affecting utility and power lines.

Under the California Emergency Services Act (Gov't Code Section 8550 et seq.) and the Tracy Municipal Code, a declaration of local emergency provides certain emergency powers and authorities to the City. Among those powers are that the Director of Emergency Services may promulgate orders and regulations necessary to provide for the protection of life and property. Additionally, under an emergency declaration, the Director of Emergency Services can further provide and receive mutual aid to any affected area in accordance with state law (Gov't Code Section 8631). This declaration of emergency is a recommended step in potentially seeking intergovernmental mutual aid, reimbursements, and other assistance, which directly helps the City's residents.

## FISCAL IMPACT

At this time the fiscal impacts to the City and the community are unknown. The adoption of this proclamation will allow the City to access resources to best respond to public health and safety needs.

## PUBLIC OUTREACH/INTEREST

The City has communicated on all of its social media forums, the resources available to the residents. Additionally, signs have been posted throughout the parks and public areas warning residents of the dangers of fallen trees and flooded areas.

#### COORDINATION

The City is coordinating with other local agencies, including San Joaquin County, South San Joaquin County Fire Authority, Tracy Police Department, and PG&E to access resources to help City residents.

## STRATEGIC PLAN

This agenda item supports Council's Public Safety Strategic Priority: To enhance community safety by promoting a responsive public safety system that includes civic engagement and partnerships, community involvement, public education, and prevention, intervention and suppression services that meet the needs of Tracy residents.

#### **PROCLAMATION 2023-01**

#### PROCLAMATION OF THE CITY COUNCIL OF THE CITY OF TRACY CONFIRMING THE EXISTENCE OF A LOCAL EMERGENCY RELATED TO THE SEVERE WINTER STORM

WHEREAS, Section 3.24.050 of the Tracy Municipal Code empowers the City Manager in his or her capacity as the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when said City is affected or likely to be affected by the actual or threatened existence of conditions of disaster or of extreme peril to the safety or person and property; and

WHEREAS, conditions of extreme peril to the safety of persons and property arose within the City of Tracy caused by extreme weather including high winds, flooded areas, fallen trees and utility lines, and power outages; and

**WHEREAS,** California Governor Newsom declared a state of emergency on January 4, 2023, due to severe weather that is affecting the state; and

**WHEREAS**, the extreme weather conditions warranted and necessitated the proclamation of the existence of a local emergency; and

**WHEREAS**, the proclamation of a local emergency will help the City of Tracy in addressing the needs of the residents by allowing the flow of resources into the City faster; and

**WHEREAS**, the Director of Emergency Services of the City of Tracy did proclaim the existence of a local emergency within the City on January 4, 2023, at which time the City Council of the City of Tracy was not in session; and

WHEREAS, since the City Council was not in session when the proclamation was made, California Government Code section 8630 requires the City County to ratify the proclamation if the emergency is anticipated to last more than seven (7) days, and it is anticipated that the severe weather conditions will last another ten (10) days; and

**WHEREAS**, the City Council of the City of Tracy does hereby find that conditions of extreme peril to the safety of persons and property have arisen within the City of Tracy caused by a severe winter storm; now, therefore, be it

**PROCLAIMED:** The City Council finds that:

- 1) The facts set forth in the recitals are true and correct.
- 2) The proclamation of the existence of a local emergency, as issued by the Director of Emergency Services, is hereby ratified.

3) The local emergency proclamation shall be deemed to continue to exist until the termination is proclaimed by the City Council of the City of Tracy.

**FURTHER PROCLAIMED AND ORDERED:** That during the existence of the local emergency, the powers, functions, and duties of the emergency organization of this City shall be those prescribed by state law, ordinances, and resolutions of this City and by the City of Tracy's Comprehensive Emergency Management Plan.
