REQUEST

REVIEW AND PROVIDE INPUT ON DRAFT CHANGES TO TRACER BUS SERVICE

DISCUSSION

The Tracer bus service provides three main public transit services to the residents of Tracy: Tracer Fixed Route bus service, Tracer Paratransit bus service for ADA and senior passengers, and TracerPlus general public on-demand service.

Periodically, the transit service needs of the community are evaluated based on a number of factors including current development, use of existing services, and requests from the public evaluated through the Unmet Transit Needs process. After evaluating a number of these factors, staff is recommending some changes to the current service in an effort to provide improved service within the City of Tracy. The following are potential changes to be implemented effective July 1, 2023.

DRAFT TRACER REVISIONS:

- Eliminate the last loop of Monday through Friday service on Routes A, B, C, and D
 - These last loops are historically low in ridership. Current data shows that there are an average of approximately 1.47 passengers per route riding during the last loops of all four routes.
 - This will result in the fixed route ending at approximately 7pm for routes A and B, and at approximately 6:15pm for routes C and D.
 - This service will be replaced by starting the TracerPlus service earlier in an effort to still allow those riding at this time to get to their destinations.
 - This will result in a reduction of approximately 1,100 fixed route revenue hours.

Reduce Paratransit hours to coincide with Tracer Fixed Route reduction

- Tracer is required to provide complimentary paratransit service during the hours that fixed route service is in operation. With the reduction in fixed route hours, it is recommended to reduce the paratransit hours as well.
- Ridership during this time frame is generally low, with an average of .27 passengers per day riding at this time, or approximately one rider every 4 days.
- This will result in paratransit service ending at 6:30pm Monday through
 Saturday instead of 8pm on weekdays and 7pm on Saturdays.

- By increasing the TracerPlus service hours, these passengers will still be able to have transportation options during this time of day.
- This will result in a reduction of approximately 780 paratransit revenue hours.

Increase TracerPlus service hours to cover the reduction in fixed route and paratransit

- It is recommended that Tracer Plus hours be increased by 1.5 hours during the weekday, with service starting at 6:30pm instead of 8pm, in order to accommodate the reduction in fixed route and paratransit service.
- This will result in an increase of approximately 1,170 TracerPlus revenue hours.

Create a new commuter route to service the Tracy Hills and Ellis developments

- Development in these areas is continuing to happen at a rapid pace. There have been more and more requests for service to these developments. As a start, we suggest providing commuter route service in these areas to allow students to use the bus in the morning and afternoon. TracerPlus is available in the mornings and evening currently, as well as Paratransit service throughout the day.
- Providing two loops per day, Monday through Friday, will result in an increase of approximately 1,040 fixed route hours.

Continue the pilot program of Route H to the Temporary Housing Shelter on Arbor Road

With the opening of the Temporary Housing Shelter in November, Tracer was asked to provide service to that area. As a result a pilot route (Route H) was created to service the site. As this route has only been running for a few months, it is suggested that the route be continued as a pilot program and to further assess its effectiveness after it has been in operation for a longer period of time.

Implementation of pilot ACE Shuttle Service to Ellis and Tracy Hills Subdivisions

- We have received information from the San Joaquin Council of Governments (SJCOG) that during the Unmet Transit Needs Process, there were a significant number of comments regarding a shuttle service to the ACE station from the Ellis subdivision. As a result it is recommended that a pilot shuttle service be implemented to serve the Ellis and Tracy Hills subdivisions.
- Based on current information, we will anticipate meeting the latter three trains in the morning and the first two trains in the evening. TracerPlus can be used to service passengers who require meeting the other trains in the morning and evening.
- It is estimated that by running three loops in the morning and two loops in the afternoon that it will require an additional 1040 revenue hours.

• Create a monthly fixed route pass, and eliminate the weekly pass

o In an effort to encourage additional usage of the fixed route, it is proposed that we explore eliminating the weekly pass and instead create a monthly pass. The monthly pass would be offered at a discounted rate compared to buying two single ride tickets every day for the month.

The current Tracer system operates with approximately 36,800 vehicle revenue hours. Factoring in the various revenue hour reductions and additions as mentioned above, it is anticipated that the proposed changes would result in approximately 38,150 vehicle revenue hours, and overall increase of approximately 1,350 hours. These additional hours can be absorbed under the current operating contract with MTM Transit.

FISCAL IMPACT

There is no fiscal impact to the General Fund, Transportation Fund or Airport Fund for this item at this time.

RECOMMENDATION

That the Commission review and provide input on the draft changes to Tracer bus service.

TRACER Ridership: A year-to-date comparison of current ridership compared to the same period in the previous year is shown below. Fixed route ridership is up 8,888 riders compared to the year-to-date ridership in December FY 21/22, an increase of approximately 22%. Paratransit ridership is up 1,910 riders compared to the same time in December FY 21/22, an increase of approximately 35%. Overall the Tracer system ridership has increased by 10,798 riders over the same period last year, an overall increase of approximately 23%
