### TRACY CITY COUNCIL - SPECIAL MEETING MINUTES

# December 13, 2022, 6:00 p.m.

Tracy City Hall, 333 Civic Center Plaza, Tracy, CA.

Mayor Young called the meeting to order at 6:13 p.m.

Mayor Young led the Pledge of Allegiance.

Rabbi Levi Meijers, Chabad of Tracy Jewish Center offered the invocation.

Roll Call found Council Members Arriola, Bedolla, Davis, Mayor Pro Tem Vargas and Mayor Young present.

1. ITEMS FROM THE AUDIENCE - Robert Tanner stated he hoped the new City Council will work for the City, not for themselves and not their own personal agendas.

Patricia Howell stated she attended the Lawrence Livermore National Laboratory (LLNL) hearing regarding their 15-year plan and was disappointed there was no representation from City government and the citizens. LLNL wants to add testing on certain hazardous materials and expand buildings that have not been cleaned and stated the City should agendize the item so they can respond to the plan before being approved.

# 3.D THE CITY COUNCIL, BY MOTION, APPOINT A COUNCIL MEMBER AS THE MAYOR PRO TEMPORE OF THE TRACY CITY COUNCIL FOR A TWO-YEAR TERM ENDING IN DECEMBER 2024.

Charles Jones encouraged appointment of Dan Arriola as Mayor Pro Tempore and shared some of his accomplishments.

Veronica Vargas, former Mayor Pro Tem asked the Mayor to consider nominating and appointing Council Member Arriola to the role as Mayor Pro Tempore and shared some of his achievements.

Council Member Bedolla disagreed with a characterization made by Veronica Vargas.

Robin Cole encouraged Dan Arriola as the only choice as Mayor Pro Tempore.

A resident read comments from Lisa Roth who shared support for appointment of Dan Arriola as Mayor Pro Tempore and shared his accomplishments.

Pat Howell shared support for Dan Arriola as Mayor Pro Tempore.

Virna Hudson shared support for Dan Arriola as Mayor Pro Tempore.

William Muetzenberg supported Dan Arriola as Mayor Pro Tempore.

Karin Moore shared support for Dan Arriola as Mayor Pro Tempore.

Rhodesia Ransom urged Mayor Young to nominate Council Member Arriola as Mayor Pro Tempore.

Mayor Young announced there were four emails received from Kaia Garza, Amir Abboushi, Vianna Dayeh and Diego Bejarano in support of Council Member Bedolla as Mayor Pro Tempore.

Council comments followed.

Council Member Bedolla motioned to appoint himself as Mayor Pro Tempore of the Tracy City Council for a two-year term ending in December 2024. There was no second to the motion.

Mayor Young motioned to appoint Council Member Arriola as Mayor Pro Tempore. Council Member Arriola accepted the nomination and seconded the motion.

Council Member Bedolla requested to make a substitute motion.

Bijal Patel, City Attorney responded since the motion has not been voted on a substitute motion could be made.

Council Member Bedolla asked Council Member Evans if he would be interested in serving as Mayor Pro Tempore. Council Member Evans responded since it is his first day, the constituents at this time would not want to see him nominated to this position.

Council Member Bedolla made a substitute motion to appoint Council Member Davis as Mayor Pro Tempore for a two-year term ending in December 2024. Council Member Evans seconded the motion.

Council comments continued.

## **ACTION:**

Motion was made by Council Member Bedolla and seconded by Council Member Evans to appoint Council Member Davis as the Mayor Pro Tempore of the Tracy City Council for a two-year term ending in December 2024. Roll call found Council Members Bedolla, Davis and Evans in favor; passed and so ordered. Council Member Arriola and Mayor Young opposed.

4. COUNCIL ITEMS AND COMMENTS – Council Member Arriola thanked everyone who came out for the Oaths of Office, stated he was looking forward to working with the Council and wished everyone a Merry Christmas and happy new year.

Council Member Evans seconded what Council Member Arriola said and stated Council Member Arriola was the first to congratulate him. Merry Christmas to residents and be safe. Check wiper blades and treads on tires before travelling and safe travels.

Council Member Bedolla wished everyone a Merry Christmas.

Mayor Young thanked everyone for coming out, encouraged everyone to continue to raise their voice, and announced there will not be a regular Council meeting on December 20, 2022 and January 3, 2023, and first meeting will be on January 17, 2023 and wished everyone a Merry Christmas.
