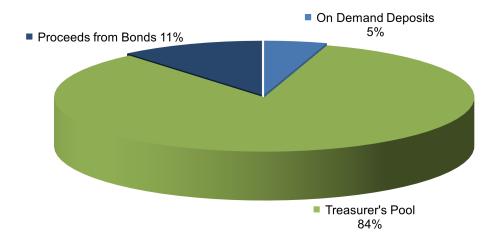

City of Tracy - Investment Summary October 31, 2022 \$463,938,670.87 Market Value



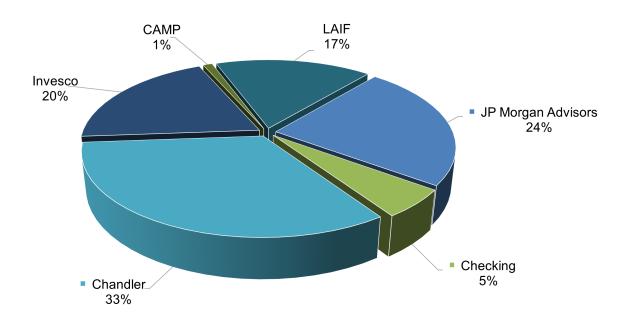

City of Tracy - Investment Summary December 31, 2022 \$455,318,094.26 Market Value



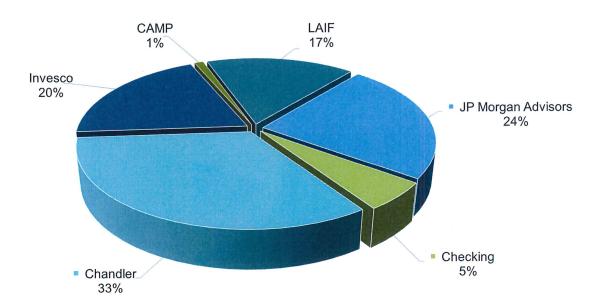
