City Council Members and Acting City Manager,

Unfortunately, I cannot be at the City Council meeting tonight to give public comments due to illness. I am writing this letter in support of Machucas Kitchen (previously known at other locations as Johnny's Diner & Creamery. This is a well-known, well-loved, and established business that had to relocate multiple times due to lease and landlord changes They have now purchased an abandoned piece of land and are bringing vitality to it

While technically their kitchen is in a "food truck" vs a brick-and-mortar building, it is no different than other restaurants downtown that offers outdoor dining. This is not a food truck that travels from place to place and that parks along the side of a street. It is not a temporary location. They have established a permanent location. They don't impede traffic or park in front of competitors. They are bringing life and new business to an unused area.

I understand that the City of Tracy has a Mobile food vendor ordinance that does not allow food trucks inside city limits. The owners have petitioned to amend the ordinance since they're not a mobile business that sets up temporarily. This is the permanent location. The permit expires on March 14th. The City MUST make the amendment so permanent businesses that meet health and safety standards as required by both City and Count ordinances, which this business does, can set up outdoor eateries.

An outdoor eatery in a permanent location is not a mobile food vendor. It is a permanent food kitchen utilizing a food truck structure instead of a brick-and-mortar building. Their outdoor dining space is the same as multiple businesses downtown that offers outdoor dining including Bistro 135, Junior's, Town & Country, and The Station. As a city resident and supporter of small businesses, I do not see a difference between Machucas Kitchen (aka Johnny's Diner & Creamery) and these other businesses outside of not having an indoor dining option.

As a City that claims to support small businesses and family-run businesses, it is time the City and its governing body step up and prove it, by doing what is right and making these changes.

Thank you for your time and consideration of this matter. I look forward to continuing to support this locally owned business and hope the City Council does the right thing.
