PUBLIC HEARING NOTICE

The City of Tracy City Council will conduct a Public Hearing on Tuesday, June 6, 2023, at 7:00 p.m., or as soon thereafter as possible, in the Tracy Council Chambers, 333 Civic Center Plaza, to consider:

The Tracy Alliance applications, City Council action to adopt an ordinance to 1) certify an Environmental Impact Report (EIR) and adopt a Mitigation Monitoring and Reporting Program (MMRP) and findings of fact and a statement of overriding considerations (together, CEQA Findings) for the annexation and future development of industrial buildings on a 191.18-acre property located at the northeast corner of Grant Line and Paradise Roads, (Assessor's Parcel Numbers 213-170-14, -24, -25, -26, -27, and -48) in accordance with the California Environmental Quality Act; 2) Amend the Northeast Industrial Specific Plan (NEI) to add the subject property to said specific plan with the land use designation of Light Industrial (SPA22-0003); and 3) approve an annexation and rezoning of the property to Northeast Industrial Specific Plan (AP20-0003) and 4) approve the submittal of a petition to the San Joaquin County Local Agency Formation Commission (LAFCo) for annexation of the property to the City of Tracy.

On January 25, 2023, by a vote of 4-0, with one Planning Commissioner absent, the Tracy Planning Commission recommended approval of the applications to annex the property to the City limits, amend the Northeast Industrial Areas Specific Plan to include the property with a Light Industrial designation, and rezone the property to Northeast Industrial Areas Specific Plan.
