In December 2022, the On Demand Deposits were at \$23,202,854.33 at the end of the second quarter. Treasurer's Investments Market Value was \$393,199,342.61 and Bond Proceeds totaled \$38,915,897.32

Grand total of all investments was \$455,318,094.26 in Market Value. Treasurer's Pool 86%, Proceeds from Bonds 9%, and On Demand Deposits 5%.

Treasurer Report Highlights:

#### Treasurer's Investments

- The Wells Fargo Sweep Account Book Value is \$23,164,523.33 and checking \$38,331.00. This account earns no interest.
- Chandler Asset Management \$145,546,642.63 Book Value and \$138,861,745.51 Market Value. Average maturity 708 days with an interest rate of 1.77%.
- JP Morgan Securities \$102,895,517.53 Book Value and \$99,557,042.78
  Market Value which is at par. Average maturity 376 days with an interest rate of 1.46%.
- Invesco \$86,270,228.60 Book Value and \$81,629,147.27 Market Value.
  Average maturity 843 days with an interest rate of 2.13%
- Local Agency Investment Fund (LAIF) \$69,042,637.38 with an interest rate of 2.17%
- CAMP \$4,108,769.67 with an interest rate of 4.30%.
- The average interest rate of the portfolio as of December 2022 was 1.734% with 515 days to maturity.
