The City of Tracy City Council will conduct a Public Hearing on Wednesday, July 5, 2023, at 7:00 p.m., or as soon thereafter as possible, in the Tracy Council Chambers, 333 Civic Center Plaza, to consider:

Valpico Road Zone Amendment from Light Industrial to High Density Residential: Application Number R21-0005. The proposal is to amend the zone district from Light Industrial (M-1) to High Density Residential (HDR) of approximately 35 acres located on the north side of Valpico Road, approximately one-quarter mile east of Tracy Boulevard, between the Raley's shopping center and Altrium Packaging. The site includes five parcels, City right-of-way, a future City of Tracy storm drain pond site, and the Byron Bethany Irrigation District Canal on the north side of the site (Assessor's Parcel Numbers 246-130-03, 04, 06, 26, 27, and a portion of 246-010-08). The proposal will bring the zoning into consistency with the existing General Plan designation, which is Residential High. No development application or specific proposal for private, on-site improvements is currently proposed or being processed for any portion of the site. The proposal does not increase the development density established by the City's General Plan and therefore, in accordance with CEQA Guidelines Section 15183, does not require additional environmental review. On November 17, 2021, by a vote of 5 to 0, the Tracy Planning Commission recommended approval of the zoning district amendment.
