Dear Mayor Young and Council Members Arriola, Bedolla, Davis and Evans,

I am writing regarding the actions of City Attorney Bijal Patel.

It has recently come to light, at least to the residents of Tracy, that City Attorney Patel had her license to practice law suspended by the State Bar of California. Yet it appears she continued to practice law as the attorney of record for the City of Tracy.

It is my understanding that City Attorney Patel failed to complete and/or notify the State Bar of continuing education and/or certification requirements despite ample notice to do so.

It is my understanding that her contract states her employment is terminated if she fails to abide by the terms of her contract by maintaining an active law license. Yet it appears she is still employed.

Why is her continued employment a subject for discussion? Shouldn't she have been terminated at the time she violated her contract on 7-1-23?

Three councilmembers advocated for changing the number of council votes required to dismiss the City Manager but not the other at-will employee, the City Attorney. Is it possible they knew at the time of the vote that city Attorney Patel's law license was at risk of suspension? Was it a coincidence or insurance that her employment would be subject to the same vote standard?

City Attorney Patel has deceived the City of Tracy. She has continued to give advice at City Council meetings. She has possibly put the city at risk if she signed official documents while suspended.

I have observed many city council meetings, either in person or online. I have listened to various council members talk about ethics, divisiveness, level accusations regarding the former city Manager and the need to censure Mayor Young.

It will be interesting to see if they will also apply those beliefs when determining if the City Attorney, with whom they have a friendly ally with regard to her support of their agenda, should be dismissed for violating her contract.

Mayor Young and Tracy City Council,

This is unprecedented!

Our City Attorney has practiced law for almost 27 years and as an "Officer of the Court" she knowingly failed to fulfill her obligation of 25 hours of MCLE within 3 years but the State Bar gave her almost 3-1/2 years and still she neglected her responsibility—this is not a simple administrative error!

She was sent numerous notifications from the State Bar.

And once her license was inactive, law requires her to serve notice to the highest authorized officer or employee of her license status which did not happen.
