Bijal Patel, City Attorney stated due to any potential conflict of interest, the City Attorney's Office has engaged the law firm of Best, Best and Krieger (BBK) to serve as special counsel on this item. Attorney John Natalizio from BBK provided the staff report and responded to questions.

Council Member Bedolla indicated that there was a typo on page two, fourth paragraph where it states, "contact amendment" it should be corrected to say, "contract amendment".

Council Member Evans indicated that there was an additional typo also on page two on the fifth paragraph where it states, "the public was afforded and opportunity" "and" should be corrected to "an".

There was no public comment.

Mayor Young asked for clarification regarding the difference in wording between "technically and acknowledge" as it pertains to the letter. Mr Natalizio from BBK provided clarification. Council questions and comments continued.

Mayor Pro Tem Davis proposed that in section three it is clear that there is an acknowledgement of a violation but that in page two, there is no need for "even if there was a violation" given that it's been acknowledged.

Mr. Natalizio BBK Attorney, summarized that Council recommends the amendments to the letter as follows: the elimination of the phrase "even if there was a violation" from page two on the second to last paragraph and the correction of multiple typos.
