Committee Member McCray provided an overview of the June 2023 Treasurer's Report, which is all-inclusive of the fourth quarter.

In June 2023, the On Demand Deposits were at \$23,719,940.09 at the end of the fourth quarter. Treasurer's Investments Market Value was \$428,781,758.36 and Bond Proceeds totaled \$46,130,556.81.

Grand total of all investments was \$498,632,255.26 in Market Value. Treasurer's Pool 86%, Proceeds from Bonds 9%, and On Demand Deposits 5%.

Treasurer Report Highlights:

Treasurer's Investments

- The Wells Fargo Sweep Account Book Value is \$23,696,168.09 with an interest rate of 0.64%. Checking account balance is \$23,772.00.
- Chandler Asset Management \$151,685,930.31 Book Value and \$145,804,691.60 Market Value. Average maturity 748 days with an interest rate of 2.18%.
- JP Morgan Securities \$133,368,177.24 Book Value and \$131,117,936.76 Market Value which is at par. Average maturity 405 days with an interest rate of 2.38%.
- Invesco \$92,023,381,37 Book Value and \$87,778,277.63 Market Value. Average maturity 836 days with an interest rate of 2.54%
- Local Agency Investment Fund (LAIF) \$59,871,080.94 with an interest rate of 3.26%
- CAMP \$4,209,771.43 with an interest rate of 5.24%.
- The average interest rate of the portfolio as of June 2023 was 2.398% with 540 days to maturity.

Proceeds from Covenant Reserves

• Total Bond Covenant Reserves for December is \$46,130,556.81.

Statistical Summary

• Committee Member McCray reviewed the Statistical Summary. The average interest rate for June was 2.398%. Pooled Investments Interest Earnings net was \$421,599.27.

• Committee Member McCray reviewed the portfolio, explained the liquidity of the portfolio, and went over the different types of investments allowed as stated in the City of Tracy Investment Policy that is approved by the City Council.
