Commissioner English stated she has been studying the Industrial and Residential RGA charts and noticed a drastic increase in infill projects. Commissioner English asked if they are subject to the Measure A cap. Scott Claar, Senior Planner, reminded the Commission that the Growth Management Ordinance and GMO Guidelines are on the City's website, and advised that infill projects are subject to the Measure A cap, except for projects with 4 or less homes, which are exempt.

Chair Orcutt inquired about the nationwide website *zoneatlas.org*, after hearing an advertisement. Scott Claar, Senior Planner, was not familiar with the website and advised that the City does not use this website, but reassured that all zoning of the City's zoning information can be found on the City's website.
