JANUARY 11, 2024

- 1. CALL TO ORDER: Vice Chair Silva called the meeting to order at 7:00 p.m.
- 2. ROLL CALL:

 - b. Absent: Gary Cooper
 - c. Staff Present: Ed Lovell, Transit Manager; Brandi Reybol, Transit Coordinator
 - d. Recorded By: Brandi Reybol, Transit Coordinator
- 3. ITEMS FROM THE AUDIENCE: John Moore, President of the Tracy Airport Association, commented that the high fuel prices at the Tracy Airport compared to similar-sized neighboring airports discourage local and visiting pilots from fueling at the Tracy Airport. He questioned why the City could not have a better fuel price even with the large volume of fuel sales with the aviation school and requested the City to be transparent.

Michael Thibodeau, Tracy, agreed with John Moore's comments on the fuel price and addressed his frustration of having to fuel at other locations due to the high price at the Tracy Airport. He suggested that the City invest in other revenue-generating ideas for the airport instead of just fuel sales and consider offering discount fuel prices to airport tenants.

5. NEW BUSINESS:

- a. Review and Provide Input on the Annual Commission Report to City Council: Staff informed the Commission regarding the upcoming Annual Commission Report to City Council on February 20, 2024. The report consists of the prior year's goals and accomplishments that were achieved. Commissioner S. Dhillon agreed to present the report. Commission discussion and questions followed.
- b. Review and Provide Updates on Commission Goals and Objectives for FY23/24

Ed Lovell informed the Commission of the outreach opportunities starting in Spring. The Short-Range Transit Plan (SRTP) consultant is currently doing data analysis and will conduct outreach in the next few months, providing the Commission with multiple opportunities to submit input. The Airport Masterplan draft has been completed, with an outreach conducted in December, and PD to present in February on bicycle traffic enforcement and e-bikes. Commission comments followed.

6. ITEMS FROM THE COMMISSION:

<u>Commissioner Francis</u>: referred to the traffic congestion on Eaton Ave. during the school bell time and mentioned that he received updates that the City Traffic Engineer reached out to the St. Bernard School Principal to assist in mitigating the traffic congestion.

<u>Commissioner R. Dhillon:</u> commented on 2023 as a good year for the Commission and appreciated the increase in audience participation. He requested information on making the meetings go live in 2024 via WebEx for more public participation. Staff agreed to bring back information.

<u>Commissioner Silva</u>: He referred to the Commission meeting recording method and inquired about Chanel 26's formal audio recording in the past. Staff provided updates on a new AV system in the plan.

Commissioner Francis: Requested for the Pledge of Allegiance at the meeting.

7. ITEMS FROM STAFF:

a. Airport Projects Update: Ed Lovell, Transit Manager, referred to the Airport updates listed in the agenda. The Airport Manager could not attend the meeting. Commission was informed to contact the Airport Manager if they have questions or concerns regarding the airport projects.

John Moore, President of the Tracy Airport Association, shared his experience visiting the Old Fort Marina Airport and the information he gathered regarding eVTOL aircraft, charging stations, flight range, and usage of power required to operate electric aircraft.

Michael Thibodeau, Tracy, referred to the Dec 9th Airport Master Plan Update presentation and commented on various items the City could provide at the airport without being on the Master Plan. There is flexibility, and the City can do what it wants

- **b.** Transit Ridership and Performance Update: Ed Lovell, Transit Manager, provided updates on the Short-Range Transit Plan (SRTP) and Intelligent Transportation System (ITS) contract to be awarded at the March 2024 City Council meeting. Staff also provided updates on ridership and the new routes. Commission comments followed.

Electric Bicycles & Motorized Scooters

Electric Bicycles / Motorized Scooters

- **♦ What is an electric bicycle**?

Electric Bicycle

As defined by California Vehicle Code § 312.5(a):

An "electric bicycle" is a bicycle equipped with fully operable pedals and an electric motor of less that 750 watts.

Electric Bicycle

As defined by California Vehicle Code § 312.5(a):

An "electric bicycle" is a bicycle equipped with fully operable pedals and an electric motor of less that 750 watts.

Further divided into three classes of "electric or low-speed, speed pedal-assisted electric bicycles." Class I, Class II, Class III.

Class I

Sicycle equipped with a motor that provides assistance only when the rider is pedaling, and that ceases to provide assistance when the electric bicycles reaches 20 MPH.




Class II

 Bicycle equipped with a throttle-actuated motor, that may be used to exclusively propel the bicycle, that ceases to provide assistance when the electric bicycle reaches 20 MPH.

Class III

Sicycle equipped with a motor that provides assistance only when the rider is pedaling, and that ceases to provide assistance when the electric bicycle reaches 28 MPH.



Motorized Scooter

As defined by California Vehicle Code § 407.5:

(a) A motorized scooter is any two-wheeled device that has handlebars, a floorboard that is designed to be stood upon while riding, may have a seat, and is powered by an electric motor (or any other type of motor) that is capable of propelling the device with or without human power.



California's Electric Bicycle Laws

- Selectric bicycles are regulated like bicycles. The same rules of the road apply to both electric bicycles and human-powered bicycles, and "riders have all the same rights and are subject to all the provisions applicable to a driver of a vehicle." (§ 21200(a)(1) CVC).
- Bicyclists must ride in the same direction as traffic on the roadway and against the right-hand curb (§ 21650.1 CVC) AND if a if a bike lane has been established, shall ride within the lane (§ 21208(a) CVC).
- Electric bicycles are not subject to the registration, licensing, or insurance requirements that apply to motor vehicles.
- ♦ Must wear a DOT-approved safety helmet if under the age of 18.

California's Electric Bicycle Laws (cont'd)

Bicycles must also be operated with the following (§ 21201(a) through (e) CVC):

(a) Brake capable of making a braked wheel skid.

(b) Handlebars below the shoulders.

(c) Of a size capable of being stopped safely and being supported in an upright position by the rider.

(d) During darkness with a white lamp that illuminates the area in front of the rider and visible from 300 feet, a red reflector or red flashing light on the rear, yellow reflectors on pedals, reflectors on sides or tires with reflectors.

(e) A lamp attached the operator meeting criteria in subdivision (d).

City of Tracy Bicycle Ordinances

Tracy Municipal Code, chapter 3.20 article 2:

- * § 3.20.100 Riders must not ride on the sidewalk unless a child is under 8 years of age.
- ♦ § 3.20.110 Must keep right of roadway.
- ♦ § 3.20.130 Must ride on a seat, passengers must also ride on a seat rear of the operator.
- ♦ § 3.20.140 Can't hitch a ride on a moving vehicle.
- ♦ § 3.20.150 Obey traffic signs and signals.

Motorized Scooter Laws

§ 21223 CVC – Lighting requirements

*Basically, same requirement as bicycles/e-bikes.

- (a) Every motorized scooter operated upon any highway during darkness shall be equipped with the following:
- (1) Except as provided in subdivision (b), a lamp emitting a white light which, while the motorized scooter is in motion, illuminates the highway in front of the operator and is visible from a distance of 300 feet in front and from the sides of the motorized scooter.
- (2) Except as provided in subdivision (c), a red reflector on the rear that is visible from a distance of 500 feet to the rear when directly in front of lawful upper beams of headlamps on a motor vehicle.
- (3) A white or yellow reflector on each side visible from the front and rear of the motorized scooter from a distance of 200 feet.
- (b) A lamp or lamp combination, emitting a white light, attached to the operator and visible from a distance of 300 feet in front and from the sides of the motorized scooter, may be used in lieu of the lamp required by paragraph (1) of subdivision (a).
- (c) A red reflector, or reflectorized material meeting the requirements of Section 25500, attached to the operator and visible from a distance of 500 feet to the rear when directly in front of lawful upper beams of headlamps on a motor vehicle, may be used in lieu of the reflector required by paragraph (2) of subdivision (a).











Seal Coat Projects

- Sealcoating is a thin coating of a mixture consisting of oil, aggregate, and polymers that seals and protects the pavement from the damaging effects of the sun's ultraviolet light and rainwater runoff. This preventative maintenance process is a cost-effective measure to prolong the life of City streets and maximize the value of previous investments.
- In 2023 the Elissagaray seal coat project, spanned over 11 lane miles of proactive infrastructure maintenance for an additional 5-7 years.
- In 2024 Eastlake Neighborhood will begin, working south when finished.





Signs & Markings Division

- 1755 RPMs (raised pavement markers) replaced
- 3140 reflectors, while also re-thermoplastic
- 60 crosswalks, 86 stop bars, and 56 stop legends
- Installed new California code green bike lanes on Elissagaray Dr. Additionally, as part of the Elissagaray neighborhood seal coat project, the division installed 18 crosswalks, 36 stop bars, and 56 stop legends.

Fixed route ridership is up 19,541 riders compared to the year-to-date ridership in February FY 22/23, an increase of approximately 29.6%. Paratransit ridership is up 2,876 riders compared to the same time in February FY 22/23, an increase of approximately 29%. Overall, the Tracer system ridership has increased by 22,417 riders over the same period last year, an overall increase of approximately 29.5%.
