International Parkway, Accessors Parcel Number 209-480-05; and (2) determining that this project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15162, which pertains to individual activities, such as the proposed Project, being carried out under the same authorizing statutory or regulatory agency of an approved Program EIR, such as the Cordes Ranch Specific Plan (CRSP) EIR and as defined under Section 15168.(c) et seq., and pursuant to CEQA Guidelines Section 15162 no subsequent EIR shall be prepared for a project that has a certified EIR, unless substantial evidence has been determined.
