As additional information I have attached is a list of ever instance when she has publicly announced she had a conflict of interest and could not participate in the matter. Between December 2021 and April 2023 Ms. Davis on publicly announced on sixteen occasions that a conflict was present and recused herself from the item. On several occasions she indicated she "needed" to recuse herself (that is her recusal was compelled) based on advice from legal counsel.

This constant and repeated practice only makes the recent participation even more egregious.

Reading thru the staff report, I was stuck by several items.

- 1. The project amount of 55 million established by city staff for a public amenity with the ability to serve more people recreationally than any other in Tracy. Legacy Fields just finished their first phase, and they are already at approximately 70 million. This is not a dig at Legacy Fields, just pointing out the disparity. I believe the multi-gen center is also higher and cannot accommodate nearly the number of patrons the swim center can.
- The language that attempts to negate the contributions from certain community members who have been consistently showing up for nearly 20 years trying to move the swim center project forward, by citing a resolution to disband the Tracy Tomorrow and Beyond Committee.
- 3. And on Page 7, titled Coordination, which included the Project Management team for Griffin Structures who are being paid \$750,000 to consult with city staff on the project and would be tasked with creating their own design. I'm sure there was no bias there, right?

The staff report also shows a reduction of the cost by eliminating the indoor pool and activity center, neither of which have been part of the community designed plan for many years, and were not included in the plans Surland submitted to the city.

The characterization of Luxury Cabanas, also known shade structures which can be used for family parties, is meant to imply "this is just too much luxury for Tracy". It's important to recognize this is a facility that will be owned by the city. They can set whatever prices they want. They don't have to even charge for a cabana, it could be based on an online reservation.

The Surland plans are ready to go to construction documents. The alternate use of Base Program option B lists a project completion of May 2027

Start building the Surland plans now, before the price of construction goes up even more and further erodes the number of swim center elements that can be built.
