1. ITEMS FROM THE AUDIENCE

Tiffanie Heben of Tracy and David Bermillo of Tracy were in attendance. Ms. Heben, a 2023 Re-Granting Program Grantee, provided an informational overview of her project, *Artists by Artists – Tracy's Creative Community Past and Present*. She stated that the Tracy Arts Commission's support was multiplied through the connections and collaborations in both the creative community, and community-at-large. Mr. Bermillo spoke about his experience hosting Open Mic Night at the Grand. He acknowledged the positive impacts on youth participants and encouraged the Commission to continue to support young creatives in our community.

Commissioner Jones will present the fourth slide for the Re-Granting Program and Open Mic Night. Vice Chair Dhugga will present the fifth slide for 2024 Goals. Commissioners agreed to bring their scripts to the May meeting for a read through.

Staff and Commissioners reviewed the schedule for the community mural project workshops with José Luis Piña Moralez on Friday, April 12 from 5 to 8 pm and Saturday, April 13 from 10 am to 2 pm. CAS Wilson advised that participant waivers and hospitality will be available in the Children's Studio on both days. Channel 26 is expected to visit to take photos of the activities and the artist at work. The mural will be on display in the Studio Theatre for Open Mic Night on April 18, then on display in the Pombo Lobby for the remainder of the month.

5. CONTINUE DISCUSSION OF 2023-24 FUNDING AND PROGRAMMING RECOMMENDATIONS

CAS Wilson provided the Staff Report. Commissioners discussed reallocation of the \$4,000 originally expected to the fund the 2024 Re-Granting Program.

Commissioners agreed to increase the June Artwalk participant hospitality to \$1,000, and support up to eight Emerging Artists presentations at \$200 each. Commissioners will seek a caterer or restaurant who can provide boxed meals and a special dessert for Artwalk participants. CAS Wilson advised that Artwalk hospitality will need paid for before or by June 20.

In addition, Commissioners agreed to provide hospitality for events at the Grand including the Tracy Theater Arts Collective's The Great Show on April 12 and Open Mic Night on April 18. CAD Staff will manage these efforts accordingly. CADM Cross reviewed and approved these allocations.

DISCUSSION

Tracy Arts Month is an annual celebration of creativity and culture organized by the Cultural Arts Division in the City of Tracy. A series of public events featuring artists and arts organizations from the across the local area is promoted and presented across the month of April.

The Tracy Arts Commission (TAC) recommended participation in Tracy Arts Month in April, 2024, with a working budget of \$2,500 supporting the creation and display of an interactive, community mural project in collaboration with Catalina Piña, José L. CONTINUE DISCUSSION OF FY2023-24 FUNDING AND PROGRAMMING RECOMMENDATIONS

DISCUSSION

The Tracy Arts Commission's (TAC) programming funding resides in administrative accounts of the Cultural Arts Division (CAD) budget. The TAC FY23-24 allocation is \$11,790. The TAC meets annually to discuss funding and programming in effort to best meet goals.

At the meeting of May 9, 2023, the TAC approved allocation of \$3,150 in collaboration with the Grand Theatre Center for the Arts to co-present the 2023-24 Open Mic Night Event Series. This funding will support expenses associated with Emcee and/or related featured performers.

The TAC began discussion of the FY2023-24 Funding and Programming Recommendations at the meeting of September 12, and continued at the meetings of November 14 and December 12, 2023. Through this process recommendations were formed, which will serve as an outline of TAC activities and events through June, 2024. The following recommendations were approved at the meeting of January 9:
