Eligibility:

- Rebates are reserved for front or public viewed landscaped areas currently irrigated by an active potable City of Tracy water service.
- City of Tracy rebates are subject to terms, conditions, and available program funding. Please read the entire application carefully.
- Rebates are issued as a check and may take up to 8 weeks to process.
- Only one lawn and turf rebate will be given per address. Applicant must comply with water efficient landscape ordinance as part of their design and replacement process.
