Committee Member McCray provided an overview of the December 2023 Treasurer's Report, which is all-inclusive of the 2nd quarter.

In December 2023, the On Demand Deposits were at \$17,676,377.44 at the end of the second quarter. Treasurer's Investments Market Value was \$462,059,475.94 and Bond Proceeds totaled \$50,382,627.25.

Grand total of all investments was \$530,118,480.63 in Market Value. Treasurer's Pool 87% Proceeds from Bonds 10%, and On Demand Deposits 3%.

Treasurer Report Highlights:

Treasurer's Investments

- The Wells Fargo Sweep Account Book Value is \$17,648,932.44 with an interest rate of 0.71%. Checking account balance is \$27,445.00.
- Chandler Asset Management \$153,155,380.29 Book Value and \$150,554,979.83 Market Value. Average maturity 770 days with an interest rate of 2.82%.
- JP Morgan Securities \$161,992,280.89 Book Value and \$161,842,445.63
 Market Value which is at par. Average maturity 475 days with an interest rate of 4.16%.
- Invesco \$92,477,862.82 Book Value and \$90,500,462.05 Market Value.
 Average maturity 945 days with an interest rate of 2.73%
- Local Agency Investment Fund (LAIF) \$54,833,496.45 with an interest rate of 3.96%
- CAMP \$4,328,091.98 with an interest rate of 5.55%.
- The average interest rate of the portfolio as of December 2023 was 3.332% with 588 days to maturity.

Total Bond Covenant Reserves for December is \$50,382,627.25.

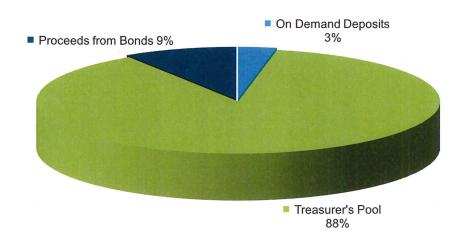

City of Tracy - Investment Summary January 31, 2024 \$551,490,695.59 Market Value



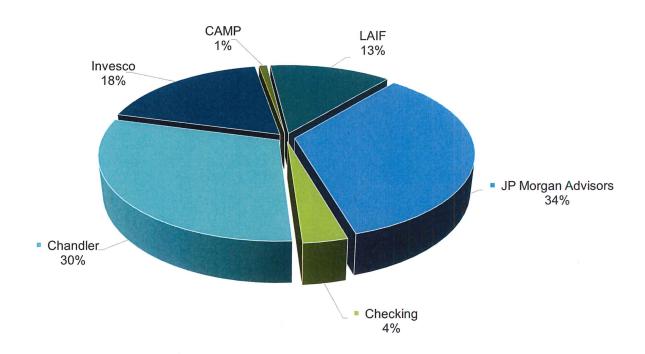

City of Tracy - Investment Summary March 31, 2024 \$543,192,543.23 Market Value



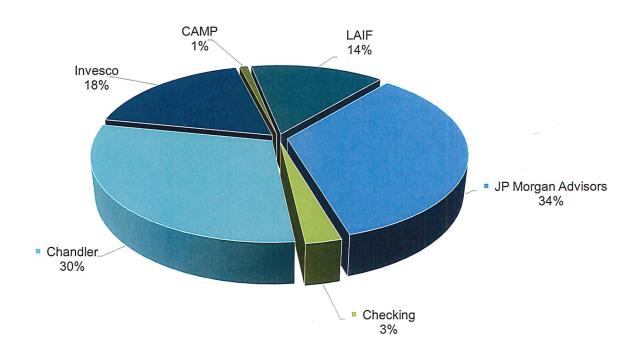
