eTRAKIT USER PERMIT APPLICATION

TERMS AND CONDITIONS

eTRAKIT is an optional Internet service provided by the City of Tracy. In consideration of being authorized to use the eTRAKIT permit system, ______ (hereinafter referred to as the "licensee") understands and agrees to the following terms and conditions:

- Only the licensee may obtain any type of building permit through the eTRAKiT Internet service. The licensee will keep confidential and shall take all necessary steps to insure that any passwords or PINs used to access the eTRAKiT Internet service shall only be used by licensee and licensee shall be fully responsible for any use of the eTRAKiT system by persons using any password or PIN issued to licensee.
- 2. All work authorized by any permit must comply with all applicable ordinances and codes adopted by City of Tracy.
- 3. All work authorized by permit is subject to inspection. Required inspections can be obtained by calling the Building Division on the inspection recorder (209) 831-6440 or via the Internet. Access must be provided for inspection purposes.
- 4. Permits shall automatically **EXPIRE**, and become void if work is not commenced within 180 days, if work is suspended, or if an inspection is not approved and recorded within 180 days.
- 5. Simple Permits are permits that do not require any discretionary approvals or plan review by the City. If, subsequent to the issuance of a Simple Permit, the Building or Planning Official determines that plans or other reviews are required for the work undertaken, the permit may be suspended or revoked until such time as proper reviews and approvals are obtained.
- 6. The issuance of a Simple Permit shall not serve to legalize other unauthorized construction, improper occupancies, additional dwelling units, or unauthorized land uses not otherwise legally established. All Simple Permits are subject to review and approval by the City of Tracy Building Safety Division.
- 7. Work shall not commence until the licensee is in receipt of an issued building permit.
- 8. The licensee must be properly licensed by the State Contractors Board to perform all work for which licensee obtains permits.
- 9. The licensee hereby certifies that all information provided both herein is correct and that all information that licensee, or licensee's authorized agents, will provide through the eTRAKiT Internet service will be correct.
- 10. Licensee shall abide by all the terms listed in the declarations on the building permit. Licensee or licensee's authorized agents must print, sign and post the permit and inspection record list at the job site.

- 11. Only the "descriptions of work to be performed" supplied by the City of Tracy within this application package shall be used to obtain permits through the eTRAKiT Internet service. All permits with unauthorized descriptions are subject to revocation.
- 12. The licensee's ability to continue to use the eTRAKiT Internet service shall be revoked if the licensee fails to adhere to any of the above noted terms or any City, State, or Federal regulations.

USING THE E-TRACKIT INTERNET SYSTEM

- To initiate the building permit process, a valid address must be entered into the eTRAKiT Internet service system. If the licensee does not have a valid address, the licensee must contact a Building Permit Technician, in the Building Safety Division at (209)831-6400, to correct any discrepancies or assign an address.
- Upon renewal of the licensee's State Contractor's License and/or City of Tracy Business License, the licensee must contact a Building Permit Technician, in the Building Safety Division at (209)831-6400 to update your file. The licensee cannot obtain web permits if the licensee's State Contractor License or City of Tracy Business License does not appear to be current in the City's tracking system.
- The eTRAKiT Internet Service Permit System is only valid for certain types of permits.
 When obtaining an eTRAKiT Internet Service permit, the licensee <u>must</u> use only the descriptions of work provided in this document and only obtain the type of permit authorized by the licensee's State Contractors License classification.

ELECTRICAL PERMITS

DESCRIPTION

Electrical Service:

▶ Repair/replace existing electrical service to residence.

<u>Note</u>: New services will not be issued on-line. Also, please check with PG&E for increased service panel amperage at your location.

MECHANICAL PERMITS

DESCRIPTION

HVAC System:

Replace residential HVAC system, (wall furnace/floor furnace/dual pack, split system).

<u>Note</u>: If gas or electrical system will need to be modified you will need to get your permit at the permit counter.

<u>Note</u>: Completed copies of the MF-1R, CF-1R, CF-6R must be available at the job site at the time of inspection. Also the CF-4R Form, if required, must be available at time of final inspection.

PLUMBING PERMITS

DESCRIPTION

Plumbing:

Repair/replace existing sewer line with approved materials, between dwelling and property line.

<u>Note</u>: Permits for sewer line repair / replacement requiring encroachment in City easements will not be issued on-line.

• Replace existing water heater with new listed water heater and vent.

<u>Note</u>: Completed copies of the Mf-1R and CR-1R B must be available at the job site at the time of inspection.
