Committee Member McCray provided an overview of the March 2024 Treasurer's Report, which is all-inclusive of the 3rd quarter.

In March 2024, the On Demand Deposits were at \$13,943,543,24 at the end of the third quarter. Treasurer's Investments Market Value was \$492,356,907.12 and Bond Proceeds totaled \$36,892,092.87.

Grand total of all investments was \$543,192,543.23 in Market Value. Treasurer's Pool 91% Proceeds from Bonds 7%, and On Demand Deposits 2%.

Treasurer Report Highlights:

#### **Treasurer's Investments**

- The Wells Fargo Sweep Account Book Value is \$13,789,207.24 with an interest rate of 0.71%. Checking account balance is \$154,336.00.
- Chandler Asset Management \$154,073,385.84 Book Value and \$151,182,748.35 Market Value. Average maturity 748 days with an interest rate of 3.04%.
- JP Morgan Securities \$173,848,436.08 Book Value and \$173,829,644.63 Market Value which is at par. Average maturity 584 days with an interest rate of 4.60%.
- Invesco \$92,510,668.66 Book Value and \$90,656,998.61 Market Value. Average maturity 1,066 days with an interest rate of 3.23%
- Local Agency Investment Fund (LAIF) \$72,299,903.17 with an interest rate of 4.22%
- CAMP \$4,387,612.36 with an interest rate of 5.48%.
- The average interest rate of the portfolio as of March 2024 was 3.735% with 623 days to maturity.

## **Proceeds from Covenant Reserves**

Total Bond Covenant Reserves for March is \$36,892,092.87.
