### EXECUTIVE SUMMARY

This agenda item seeks adoption of a resolution by the City Council authorizing the acceptance of a grant of \$12,968 from the Emergency Food and Shelter Program (EFSP) allocation to support the cost of meals and shelter bed nights at the Temporary Emergency Housing Facility Project (TEHF), Capital Improvement Project (CIP) 7112. Staff also requests the City Council appropriate the full grant funds to the Parks, Recreation and Community Services Department, Homeless Service Division, for Fiscal Year 2024-2025 (FY24/25). No match from the City of Tracy (City) is required to receive this grant.

### BACKGROUND AND LEGISLATIVE HISTORY

The Emergency Food and Shelter Program (EFSP) was created by Congress in 1983 to help meet the needs of hungry and unhoused people throughout the United States and its territories by allocating federal funds for the provision of food and shelter.

Pursuant to Council's reaffirmation of the emergency shelter crisis in August of 2022, the City Manager authorized staff to identify interim housing options for the unsheltered population within the City limits. This effort not only focuses on the housing and support, but also to prepare the residents for self-sufficiency. As a result, the development of a "Campus Concept" emerged where temporary housing and supportive services would be provided to the unsheltered population. The work to develop and provide services at this "campus" has continued and has grown to include identifying and applying for ways to offset the cost of construction, services and support provided to the unhoused residents of the campus, which has been named the Temporary Emergency Housing Facility (TEHF).

The 2024 San Joaquin County Continuum of Care Point In Time Count found that 200 unsheltered homeless individuals are living within Tracy's city limits, with 98 of them in shelter. Recognizing the importance of responding to quality-of-life issues, including the human services needs of the City's unsheltered population, the City has devoted significant resources toward addressing the impacts of homelessness within the community. Staff continues to coordinate efforts between various departments to conduct bi-weekly clean-ups of public spaces, foster partnerships with non-profit organizations to share information on services and programs with the unsheltered, secure grants to support homeless services, and continue with the construction activities of the TEHF. City staff has

worked vigorously to balance the circumstances of the unsheltered, as well as the needs of the community.

In May of 2024, the City was notified by United Way of San Joaquin County that funding was made available under the Emergency Food and Shelter Program board, Phase 41, to be utilized to supplement or extend existing resources for shelter bed nights and meals at the TEHF. In May of 2024, the City submitted a proposal, budget and Homeless Management Information System report verifying shelter bed nights to the EFSP through San Joaquin County United Way. On July 29, 2024, the City was notified that funding was awarded to the City in the amount of \$12,968 to be utilized for the costs of meals and shelter bed nights at the TEHF. The City was eligible for this funding because we are operating a shelter, offering shelter beds, and supplying meals to unsheltered residents.

### ANALYSIS AND DISCUSSION

The EFSP was created by Congress in 1983 to help meet the needs of hungry and unhoused people throughout the United States and its territories by allocating federal funds for the provision of food and shelter. The EFSP supplements the amount of money available for the cost of shelter bed nights and meals to eligible organizations on a yearly basis. Money is available every year as phases and is tracked through the EFSP portal. This is the City's very first year applying for this funding stream and the funding allocated to the City was based on the services shelter bed nights and meals that were provided to unsheltered between July 1, 2022-June 30<sup>th</sup>, 2023. Based on the information provided by the City the EFPS provided \$12,968 in grant funds to be used to supplement/extend existing resources and not to substitute or reimburse ongoing programs and services.

### FISCAL IMPACT

The Parks, Recreation and Community Services Department, Homeless Services Division will receive \$12,968 dollars in grant funds from the Emergency Food and Shelter Program. The \$12,968 dollar grant is to be appropriated to the FY24/25 Homeless Services Division operating budget. No City match is required.

### **CEQA DETERMINATION**

A Notice of Exemption was issued on October 16, 2020, for the TEHF in accordance with Government Code sections 65660-65662 for low barrier navigation Centers and Section 15269(c) of the CEQA Guidelines. This action is consistent with the project considered in the Notice of Exemption and no further environmental review is necessary.

San Joaquin County, as the responsible entity under the National Environmental Protection Act (NEPA) for the federal grants related to this Project, conducted an Environmental Assessment in 2023 and released a Finding of No Significant Impact on January 18, 2024, in compliance with NEPA and applicable federal regulations.

### STRATEGIC PLAN

This agenda item seeks adoption of a resolution approving two agreements with Pacific Gas & Electric (PG&E), for different phases of the Temporary Emergency Housing Facility (TEHF), Capital Improvement Project (CIP) 71112 Project (Project). The first is for the execution of a Gas and Electric Extension Agreement (Phase II Agreement) in the amount of \$74,873 with PG&E, for the installation of the PG&E-owned power supply equipment and new service activation for the Phase II Improvements at 370 W Arbor Avenue. Staff is also requesting the City Council to ratify a Gas and Electric Extension Agreement ((Phase III Agreement) in the amount of \$73,524.81 with PG&E for the installation of the PG&E-owned power supply equipment and new service activation for the Phase III & IV Improvements at 384 W, Arbor Avenue. The Phase III Agreement had been executed by staff based on its understanding of authority granted to the City Manager during the shelter crisis and had been overlooked in previous ratification actions that had been presented to the City Council.

### BACKGROUND AND LEGISLATIVE HISTORY

A. Early Actions to Advance the TEHF

Much of the work undertaken to make improvements and to implement services at the TEHF site commenced and occurred during the Covid-19 emergency. The TEHF site and project, for all intents and purposes, commenced on March 10<sup>th</sup>, 2020, when the City Council adopted Resolution 2020-052 "Declaring A Shelter Crisis Pursuant to Government Code Section 8698 Et Seq.", subsequent to which staff commenced the process of identifying and developing a suitable site for an emergency shelter for homeless in the City of Tracy. Many of the actions taken pursuant to this declaration were then subsequently impacted, authorized or retroactively approved by subsequent Council declarations made via emergency Ordinances 1285, 1289 and 1296, "Authorizing The City Manager To Take Certain Actions" and Resolution 2020-163 authorizing the creation of CIP 71112 for the TEHF on Arbor Avenue, to create a safe and dignified facility for residents experiencing homelessness, and which appropriated funds for the construction of CIP 71112.

From March 2020 through early 2021 staff worked to design the facility and initiated site preparations for TEHF project, Phase I work, which consisted of demolition, grading, and underground infrastructure construction. Phase I was intended to prepare for the development

and installation of Phase II housing, which came to be known as the "sprung structure", to be utilized as the TEHF shelter on Arbor. This preparation included the design and development of the necessary components required to provide permanent power (electricity) from PG&E to the facility. On April 15, 2022, staff executed a Gas and Power Extension Agreement with PG&E in the amount of \$71,442 for the installation of permanent power for the Phase II Improvements.

In the summer of 2022, the City experienced a significant setback on the bids for the installation of the sprung structure, which caused a significant delay in the completion of Phase II of the TEHF. As a result on August 16, 2022, due to this significant delay, combined with the ongoing threat to the health and safety of the unsheltered population, and in anticipation of the necessity to protect the unsheltered from exposure to harsh weather conditions during the upcoming winter season, the City Council adopted Resolution No. 2022-12, which reaffirmed an emergency shelter crisis, pursuant to California Government Code 8698.4 and authorized the City Manager, both retroactively and prospectively, to take actions needed to expeditiously provide interim housing solutions and dispensed the City's competitive bidding requirements for professional services, pursuant to Tracy Municipal Code (TMC) Section 2.20.140(b)(6). The resolution further authorized the City Manager to take any directly related and immediate actions required by the shelter emergency, without giving notice for bids to let contracts, pursuant to PCC section 22050 and TMC section 2.20.270(a).

Concurrent with the developments for permanent power to the TEHF, staff was also working on temporary and permanent power to the Phase III and IV interim site on the southern end of the TEHF shelter site. On August 2, 2023, staff executed a Gas and Power Extension Agreement with PG&E in the amount of \$73,524.81 for the installation of permanent power for the Phase III and IV Improvements which were, and continue to, be providing shelter and support services to the homeless community of Tracy. This agreement was executed by staff based on their understanding of authority that had been granted to the City Manager during the shelter crisis. It is now discovered that the execution of this Phase III Agreement had never been taken back to the City Council for ratification as had all other actions taken by the City Manager under the shelter crisis delegations of authority.

PG&E has accepted this agreement and the payment in the amount of \$73,524.81. The agreement is still active, and PG&E is performing in accordance to the terms of the agreement and the work will be completed as proposed in the agreement.

Staff remained in constant contact with PG&E regarding both the Phase II and Phase III and IV Agreements and continued to prepare the site for permanent power. Preparation for the site included the purchase and delivery of the necessary infrastructure to receive and relay power form PGE service lines.

B. Phase II Agreement

On March 21,2024 staff emailed PG&E the switchgear information for its review and approval by PG&E. PG&E responded the same day that the information is submitted to the PG&E metering department for review and comment. On July 2,2024, staff received an email from PG&E approving the equipment. On April 2, 2024, pursuant to Resolution 2024-047, the City Council approved an agreement with Nelco Electric, Inc. for the purchase of the power supply equipment, including switchgear and panel boards, for City owned power infrastructure needed for the TEHF. The equipment was received by the vendor on schedule. On May 14, 2024, pursuant to Resolution 2024-068, the City Council authorized the award of a construction

contract to Bockmon & Woody, Inc., of Stockton, for the installation of the City owned electrical infrastructure, including switchgear and panel boards. The construction began in August of 2024 and in anticipated to be complete in October of 2024.

In July of 2024, the City received a refund check in the amount of \$65,826 issued by PG&E on July 18, 2024, this amount included a deduction in the amount of \$5,617. PG&E terminated the agreement as per their terms and conditions of "the Distribution and Service Extension Agreement-Provisions (Form 62-0982)". Upon further inquiring with PG&E staff was informed that the agreement was terminated because the design and other information submitted for the agreement executed on April 15, 2022 was only valid for 18 months. After termination, staff worked with PG&E to immediately process a new application. PG&E reviewed the new application to ensure it met current code requirements and approved the resubmittal by August 8, 2024. The new (Phase II) Agreement was issued on August 13, 2024, in the amount of \$74,873, for the City's execution.

### ANALYSIS

The TEHF site has two planned power supplies, one service will serve the Phase III and Phase IV facilities and sewer lift station at the south end of the site and one service will serve the facilities being installed as part of the Phase II Site Improvements. Installation of both sets of the new equipment should be completed without impacting, affecting, or interrupting the current power supply provided by the temporary service generators to the residents and TEHF facilities. This item seeks approval for the Phase II Agreement and a retroactive ratification of the Phase III and IV Agreement.

The new Phase II Agreement, before Council for approval, is for the power supply that will serve the Phase II Improvements, commonly referred to as the Sprung Structure, that is set to begin construction with a 2025 completion date. There will be no delay to the timeline for the installation of the City owned power infrastructure equipment, including switchgear and panelboards, currently in progress, nor the construction of the Phase II improvements as a result of the PGE cancellation of the original Phase II Agreement. The current proposed Agreement will not impact shelter operations as, aside from minor inconveniences such as noise and vehicles required for construction operations, support services at TEHF should continue throughout the installation of the new PGE equipment. The installation of the PG&E owned and installed infrastructure and service connection, for the Phase II Improvements will be scheduled by PG&E once they receive the executed Agreement and payment. Energizing the Phase II power supply will be completed in early 2025, before the Phase II construction work is complete. The typical timeline for PG&E to install and energize their equipment remains at about eight to twelve weeks after PG&E's final inspection of the City installed equipment, under an approved Agreement.

The August 2, 2023, Phase II and IV Agreement is on track to be completed on schedule in October. This agreement will allow for the cessation of temporary power and the associated diesel fuel required to operate the temporary generators currently providing power to the temporary shelter site. The Phase III and IV Agreement is only being brought before Council as it affords staff an opportunity to have Council ratify the previously executed agreement.

### FISCAL IMPACT

The non-refundable fees for the canceled agreement were \$5,617. The new Agreement fee of \$74,873 is available in the project budget.

The Temporary Emergency Homeless Shelter, CIP 71112, is an approved Capital Improvement Project with a total budget of \$20,947,654. There are sufficient funds available in the project for the costs related to the Agreement, with funding as follows:

### CEQA DETERMINATION

A Notice of Exemption was issued on October 16, 2020, for the TEHF in accordance with Government Code sections 65660-65662 for low barrier navigation Centers and Section 15269(c) of the CEQA Guidelines. This action is consistent with the project considered in the Notice of Exemption and no further environmental review is necessary.

San Joaquin County, as the responsible entity under the National Environmental Protection Act (NEPA) for the federal grants related to this Project, conducted an Environmental Assessment in 2023 and released a Finding of No Significant Impact on January 18, 2024, in compliance with NEPA and applicable federal regulations.

### STRATEGIC PLAN

This agenda item is consistent with the City Council's adopted 2021-2023 Strategic Priorities, Public Safety Strategy Plan, Goal No. 2, Implementation of the Adopted Homelessness Strategic Plan, Item No. 1, to secure capital funding to construct a Temporary Emergency Housing Facility.

### ACTION REQUESTED OF THE CITY COUNCIL

Staff recommends that the Tracy Homelessness Advisory Committee recommend that the City Council adopt a Resolution: (1) Approving the execution of a Gas and Electric Extension Agreement with Pacific Gas and Electric, Inc., (PG&E) for new service activation at 370 W. Arbor Avenue for the Phase II Improvements at the Temporary Emergency Housing Facility, Capital Improvement Project 71112 (TEHF), in the amount of \$74,873; (2) Ratifying the previously executed Gas and Electric Extension Agreement with PG&E for new service activation at 384 W. Arbor Avenue for the Phase III and IV Improvements of the TEHF, in the amount of \$73,524.81.

Per Decision 23-12-037, Mixed-Fuel New Constructions project applications received after July 1, 2024, will not qualify for Allowances, Refunds, or Discount Option. For new applications for Gas Service Extension(s) on or after July 1, 2023, and Mixed Fuel New Construction projects after July 1, 2024, Applicants must pay PG&E its total estimated installed cost upon contract execution, in advance of PG&E commencing its work. Upon completion of the work and

determination of actual costs, PG&E will provide Applicant with a final invoice or refund to account for a true-up to actual costs. An Applicant's failure to pay a final invoice in a timely manner is a violation of PG&E's Gas Rules 15/16 and may result in discontinuance of service. Non-Residential Customers submitting an application for new gas service on or after July 1, 2023 may qualify for Allowances, Refunds or Discount Option if approved by the CPUC. 

(1) APPROVING THE EXECUTION OF A GAS AND ELECTRIC EXTENSION AGREEMENT WITH PACIFIC GAS AND ELECTRIC, INC.(PG&E) FOR NEW SERVICE ACTIVATION AT 370 W. ARBOR AVENUE FOR THE PHASE II IMPROVEMENTS AT THE TEMPORARY EMERGENCY HOUSING FACILITY, CAPITAL IMRPROVEMENT PROJECT 71112 IN THE AMOUNT OF \$74,873, AND

# (2) RATIFYING THE PREVIOULSY EXECUTED GAS AND ELECTRIC EXTENSION AGREEMENT WITH PG&E FOR NEW SERVICE ACTIVATION AT 384 W. ARBOR AVENUE FOR THE PHASE III AND IV IMPROVEMENTS OF THE TEHF, IN THE AMOUNT OF \$73,524.81.

**WHEREAS**, on March 10, 2020, City Council adopted Resolution No. 2020-050, which declared a shelter crisis pursuant to California Government Code Section 8698.2; and

WHEREAS, on September 1, 2020, City Council authorized the creation of a Capital Improvement Project (CIP) for the Temporary Emergency Housing Project (TEHF) on Arbor Avenue, CIP 71112 (Project) to create a safe and dignified facility for residents experiencing homelessness; and

WHEREAS, from March 2020 through early 2021 staff worked to design the facility and initiated site preparations for TEHF project, Phase I work, which consisted of demolition, grading, and underground infrastructure construction, Phase I was intended to prepare for the development and installation of Phase II housing, which came to be known as the "sprung structure", to be utilized as the TEHF shelter on Arbor; and

**WHEREAS**, this preparation included the design and development of the necessary components required to provide permanent power (electricity) from PG&E to the facility; and

**WHEREAS**, the proposed Phase II Project construction included the installation of the permanent power supply, but it was postponed due to the costs related to expediting the completion of the interim facility preparation; as a result, portable generators were leased to provide power for the site until equipment for a permanent power supply could be installed; and

WHEREAS, both Phase III and Phase IV interim housing facilities are now being powered by four (4) portable generators, consisting of two (2) primary generators and two (2) backup generators, required by South San Joaquin County Fire to maintain power to the Fire Alarm Monitoring System; Fuel costs have increased due to the higher demand of the additional facilities and residents; and

WHEREAS, on April 15, 2022, staff executed a Gas and Power Extension Agreement with PG&E in the amount of \$71,442 for the installation of permanent power for the Phase II Improvements based on their understanding of authority that had been granted to the City Manager during the shelter crisis, PG&E accepted the agreement and the payment in the amount of \$71,441.88; and

WHEREAS, concurrently with the developments for permanent power to the TEHF, staff was also working on temporary and permanent power to the Phase III and IV interim site on the southern end of the TEHF shelter site; and

**WHEREAS**, on August 2, 2023, staff executed another Gas and electric Agreement (Phase III Agreement) with PG&E in the amount of \$73,524.81 for the installation of permanent power for the Phase III and IV Improvements which were, and continue to, be providing shelter and support services to the homeless community of Tracy; and

**WHEREAS**, it is now discovered that the execution of this Phase III Agreement had never been taken back to the City Council for ratification as had all other actions taken by the City Manager under the shelter crisis delegations of authority; and

**WHEREAS**, PG&E accepted the Phase III Agreement and the payment in the amount of \$73,524.81; and

**WHEREAS**, the Phase III Agreement is still active, and PG&E is performing in accordance to the terms of the agreement and the work will be completed as proposed in the agreement terms; and

**WHEREAS**, staff remained in constant contact with PG&E regarding both Agreements and continued to prepare the site for permanent power which included the purchase and delivery of the necessary infrastructure to receive and relay power form PGE service lines; and

**WHEREAS**, on April 2, 2024, pursuant to Resolution 2024-047, the City Council approved an agreement with Nelco Electric, Inc. for the purchase of the power supply equipment, including switchgear and panel boards, for City owned power infrastructure needed for the TEHF; and

WHEREAS, on May 14, 2024, pursuant to Resolution 2024-068, the City Council authorized the award of a construction contract to Bockmon & Woody, Inc., of Stockton, for the installation of the City owned electrical infrastructure, including switchgear and panel boards, the construction began in August of 2024 and in anticipated to be complete in October of 2024; and

**WHEREAS**, in July of 2024, the City received a refund check in the amount of \$65,826 issued by PG&E on July 18, 2024, terminating the agreement executed on April 15, 2022 and this amount included a deduction in the amount of \$5,617; and

WHEREAS, PG&E terminated the agreement as per their terms and conditions of "the Distribution and Service Extension Agreement-Provisions (Form 62-0982)" and upon further inquiring with PG&E staff was informed that the agreement was terminated because the design and other information submitted for the agreement executed on April 15, 2022 was only valid for 18 months; and

**WHEREAS**, after termination, staff worked with PG&E to immediately process a new application, PG&E reviewed the new application to ensure it met current code requirements and approved the resubmittal by August 8, 2024. The new (Phase II) Agreement was issued on August 13, 2024, in the amount of \$74,873, for the City's execution; and

**WHEREAS**, staff is requesting the City Council to approve the execution of Phase II Agreement and at the same time staff is also requesting the City Council to ratify the previously executed Phase III Agreement; and

**WHEREAS**, the project is funded pursuant to City Council's approval of the Temporary Emergency Housing Facility, CIP 71112, which is an approved project in the City's Capital Improvement Plan; sufficient funds are available in the CIP for the new Agreement; and

WHEREAS, a Notice of Exemption was issued on October 16, 2020, for the TEHF in accordance with Government Code sections 65660-65662 for low barrier navigation Centers and Section 15269(c) of the California Environment Quality Act Guidelines(CEQA) and this action is consistent with the project considered in the Notice of Exemption and no further environmental review is necessary and San Joaquin County, as the responsible entity under the National Environmental Protection Act (NEPA) for the federal grants related to this Project, conducted an Environmental Assessment in 2023 and released a Finding of No Significant Impact on January 18, 2024, in compliance with NEPA and applicable federal regulations; and

**WHEREAS**, the Tracy Homelessness Advisory Committee heard this item on October 17, 2024 and recommended that the City Council adopt the proposed Resolution; and

### NOW THEREFORE, be it
