GROWTH MANAGEMENT BOARD DETERMINATION OF ALLOCATION AND EXTENSION OF RESIDENTIAL GROWTH ALLOTMENTS

DISCUSSION

This is a meeting of the Growth Management Board (GMB), and a public hearing to determine if the applicants qualify for allocation of Residential Growth Allotments (RGAs) and possible allocation, as well as extension of RGAs.

On October 16, 2012, the City Council adopted revisions to the Growth Management Ordinance (GMO) Guidelines. In August of 2015, the GMO itself was amended to allow for the City to reach compliance with the State's Regional Housing Need Allocation, as required. Although the dates listed above include the most recent revisions to the GMO and GMO Guidelines, there are several projects that were vested into previous versions of the GMO and Guidelines. Both applications to be considered at this time are for the Brookview project, which falls under the guidelines of the 2005 version of the GMO Guidelines. The project and its applications are summarized below.

RGA16-0008 - Brookview Properties, LLC - Brookview - Extension of 20 RGAs

This project received approval of a Vesting Tentative Subdivision Map in 2006, and was later amended in 2010. Because the Vesting map was approved in 2006, the project retained its rights to be vested into the 2005 version of the GMO and GMO Guidelines. These guidelines allow for RGAs to be allocated to projects for a period of two years from the allocation date. These RGAs can also be extended for a period of up to two years, according to the 2005 GMO Guidelines. This project was allocated 20 RGAs on December 29, 2014. Prior to the expiration of those RGAs, the applicant applied for those RGAs to be extended for two years. The developer has indicated that they would like to begin construction of the project this year.

RGA16-000 - Brookview Properties, LLC - Brookview - 20 RGAs

The same project and developer as discussed above is also applying for 20 new RGAs, so that they may begin construction this year, these RGAs, combined with the 20 requested to be extended, would allow them to obtain 40 building permits, or build half of the 80-unit project. Because the project is vested into the regulations of the 2005 GMO Guidelines, these RGAs would be valid for a period of two years from the date of allocation.

RECOMMENDATION

Staff recommends that the Growth Management Board extend 20 RGAs for the Brookview project for two years (until December 29, 2018) and allocated 20 new RGAs to the Brookview project in compliance with the 2005 GMO Guidelines.
