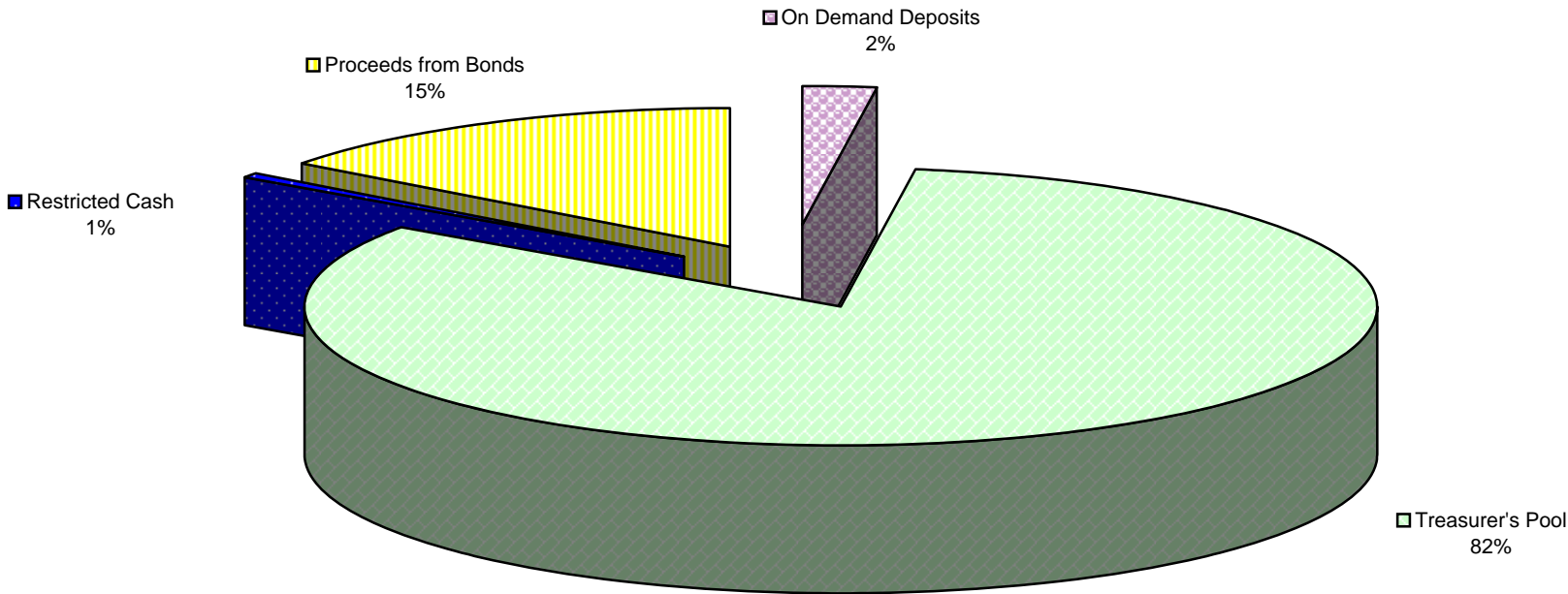

Yield to Maturity/Market

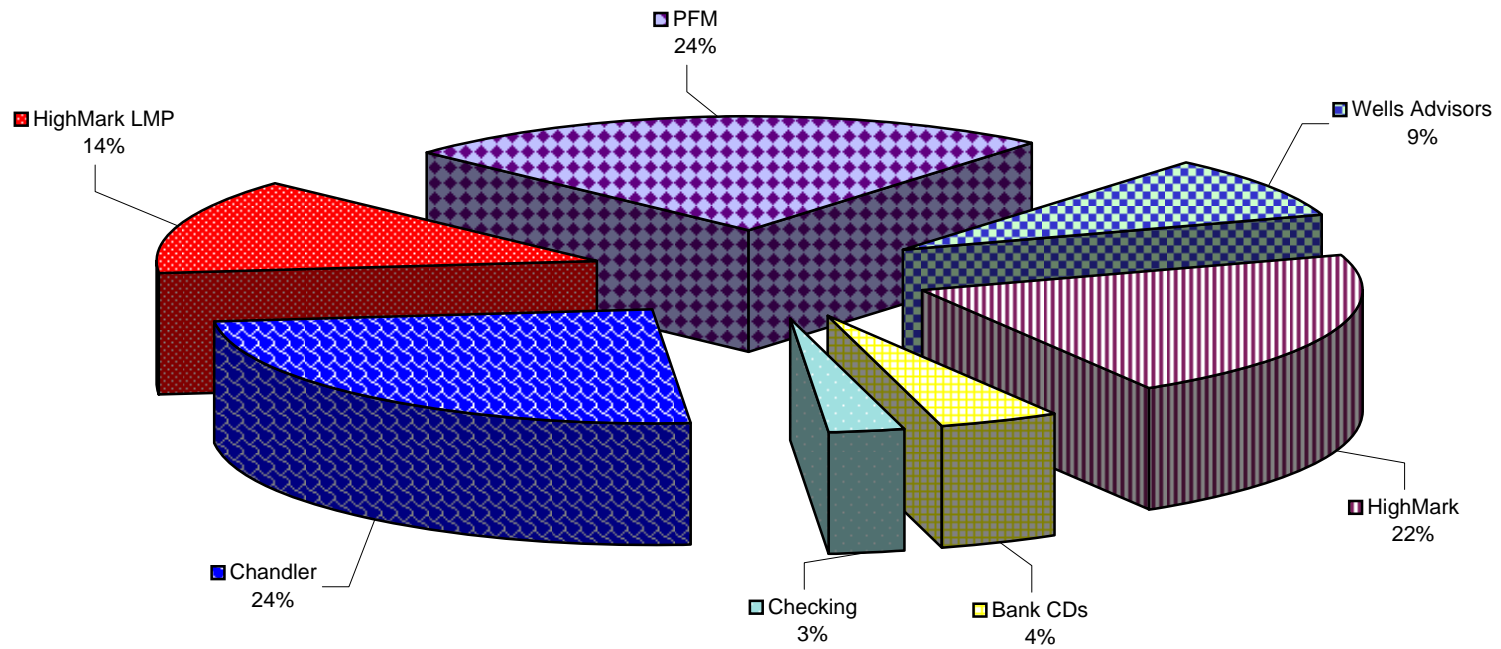
