- d. <u>Public Works Parks Maintenance Division Report</u>: Don gave the report on Lincoln Park; the irrigation is looking good, some areas are settling and seeded. PG&E made additional connections to the lights and things are coming along at the park. Rod said that the CIP was competitive and without the support of the Commissioners this project would have been difficult to get approved.
 - The playground projects; we have several LMD and a couple of general fund parks being renovated and are very close to finishing up the playgrounds. There was a walk through today at Dr. Powers and Zanussi Park. The fencing around the main

playground at Zanussi Park will come down either Monday or Tuesday of next week and there will be some clean-up work on the turf. The top lawn area will get some sod work done in the next week and will take 2-3 weeks to firm up to reopen for use. Soccer field #3 at the Sports Complex is closed until later in the month due to sod and sprinklers.

- Commissioner Jayne said that a huge chunk of fencing at Clyde Bland Park was missing and residence are using it as a personal walk way. Don said it's been that way for years. It has been repaired multiple times in a week and staff can't keep up with it; the day it gets repaired, the next day it's down. A block wall is the only thing that will resolve it.
- Commissioner Jimenez encouraged the Commissioners to continue to visit the parks; it's been an eye opener and enjoys talking to people. The children certainly enjoy the water features at the Plaza and it's becoming a center for the community which is great. There are children playing in the water and older adults sitting on the bench talking; a place where you can sit down and enjoy.
