### 6. ITEMS FROM STAFF:

a. Receive Comments and Provide Input Regarding the El Pescadero Tracy Dog Park
 – Don Scholl, Public Works Director provided the staff report.

Linda Steffens, 388 Cose Lane, provided a handout to the Commission, and outlined various needs at the park including: replacing sprinklers, replacing grass, spraying for foxtails, tree service, and additional work on the fence. Ms. Steffens provided a sample of artificial (dog friendly) turf, a sample of mulch that was recently added to the park, and gave a donation of \$205 toward the purchase of additional trees. Ms. Steffens requested additional items such as moving the signs listing dog park rules, an obstacle course for the small dog side, a canopy to protect dog owners from inclement weather, handicap access, no smoking in park, and a water feature for hot days.

Linda Jimenez joined the Commission at 7:18 p.m.

The Commissioners discussed artificial turf, bids, and Capital Improvement Projects.

Mr. Scholl outlined infrastructure challenges, the process for Capital Improvement Projects, and funding.

The Commission also discussed foxtails, partnering with non-profits, a second dog park, a shade structure, and painting the benches.

Mr. Scholl added that staff has been doing their best to address some of the concerns, and will continue those efforts.

 Review and Recommend Community Development Block Grant (CDBG) and Home Investment Partnerships Program (HOME) Funding Priorities through Fiscal Year 2021-2022 for Adoption by City Council - Josh Ewen, Management Analyst, provided the staff report.

The Commission discussed the number of homeless people, added police personnel to address the needs of homeless by providing information on where housing is and where resources are.

Ana Contreras, Code Enforcement Manager, discussed Operation Helping Hands which provides homeless individuals with information on how to make a life style change.

The Commission discussed the pros and cons of ranking various groups and upon consensus, made a recommendation to Council that the CDBG and HOME funding priorities are adopted as follows in priority rank order through FY 2021-2022:

CDBG Public Services Category:

- (1) Food Distribution Services
- (2) Homelessness Prevention, Intervention and Transitional Housing Services
- (3) Senior and Special Needs Services
- (4) Domestic Violence Services
- (5) Youth Education and Enrichment Services

CDBG Public Facilities/Improvements Category:

- (1) Public Parks and Facilities
- (2) Removal of Architectural Barriers (ADA)

#### HOME:

- (1) Address issues of public safety, health and welfare;
- (2) Rehabilitate residential properties occupied by low income persons; and,
- (3) Partner to construct income restricted family and senior housing facilities.

c. Review and Provide Input on Revised City of Tracy Sports Field Rental Handbook - Christine Mabry, Management Analyst, provided the staff report along with a copy of the revised Handbook.

The Commission discussed fees compared to surrounding cities and sunflower seed nuisances.

Robert Tanner, 1371 Rusher Street, referred the Commission to page nine of the handbook stating tournament fees were the same for the premier and regular fields.

The Commission accepted the report.

### 7. ITEMS FROM STAFF

- a. Parks & Recreation Director Report Don Scholl, Public Works Director, reported that the CPRS Conference is coming up and the early bird registration deadline is October 14. Regarding the skate park, Mr. Scholl asked if the Commission wants to see it on a future agenda. Commissioner Levoit stated he would like to see it on an agenda.
- b. Recreation Division Report Report was included as part of the agenda packet.
- c. Community Facilities Division Report No report given.
- d. Public Works Parks Maintenance Division Report
  - Parks Division Update Don Scholl, Public Works Director, stated they will be planting trees at the dog park; celebrating Arbor Day at Lincoln Park at 9:00 a.m., on October 22, which will include a short presentation, representatives from Cal Fire, the Youth Advisory Commission, and an arborist who will be planting 15 trees at Lincoln Park and many more throughout Tracy.

Larry Fisk gave the following update:

- Pre-emergent spraying in General Fund Parks has begun.
- Tracy Sports complex crew has been busy with aerating, mowing, and field preps for adult league softball and tournaments. They have also been working on the General Fund Parks with batter box repacking, pitchers mounds and leveling when time allows.
- As of October, City crews took over maintenance of the four Babe Ruth Fields at Legacy Fields, along with parking lot medians, and non-landscaped areas.
- Parks crew has been busy with general maintenance in all parks. There have been a few repairs done at the dog park at El Pescadero; mainly at the bottom of the fence by putting in boards. There are plans to relocate the benches in the dog park, as well as plant 10 trees throughout the big dog section of the park and a couple in the smaller dog park.
- Landscape Maintenance irrigation crew is continually working on irrigation.
- XL Landscape continues to move forward in getting all the parks and street scapes mowed, edged, trash picked up, and shrubs trimmed.
- West Coast Arborist has been grid trimming in the older part of downtown residential area at Tenth Street and Central Avenue, the Downtown Plaza and will be working on the Civic Center in the next couple of weeks.

### 8. ITEMS FROM THE COMMISSION:

- Commissioner Johnson asked if any work was underway to plant trees at Legacy Fields to block the wind. Mr. Scholl stated currently there was no funding, and will be looking for grant applications for next year.
- Commissioner Jimenez stated she was impressed with the dog owners' packet of information and the community outreach that is taking place.
- Commissioner Saltzman stated she was glad that the Commission has an opportunity to provide input regarding non-profit distribution of funds.
- Commissioner Birk stated he was proud of the City of Tracy cemetery that was named number one in California.
- Commissioner Johnson announced that the West Side Pioneers Museum was having a free event on Saturday, October 15, including civil war re-enactments and crafts for kids between 10 a.m., and 2:00 p.m., at 1141 Adam Street.
- Vice Chair Levoit shared the South Side Community Organization's event held on September 11, 2016. Vice Chair Levoit voiced his frustration regarding those who paid to be a part of the event and those who did not pay to be part of the event, referring to mobile vendors (carts). Vice Chair Levoit asked if smoking at parks could be reported. Don Scholl stated in all practicality it would not be enforced based on police priorities. Mr. Scholl stated he would follow up with an email back to the Commission.

# REVIEW DEVELOPMENT OF THE CITY OF TRACY CAPITAL IMPROVEMENT PROGRAM FOR FISCAL YEARS 2017-2019

### **BACKGROUND**

In the past, the City develops an annual Capital Improvement Program (CIP) to coincide with the development and approval of the annual budget each year. This year, the City is beginning a new 2-year budget cycle, which allows staff to plan for projects in 2-year increments. The CIP is a five-year document that is updated each year to reflect current projects, current priorities, and current funding. Projects in the CIP typically include project costs over \$100,000 (but may include projects of a lesser amount), have a life span of seven years or more, and result in the creation of a capital asset. The CIP also shows future plans to design and construct the city's infrastructure, whether by the City directly or as part of other development, such as future commercial or residential.

Only the projects that have been funded in a prior year, or are approved for funding in the current year, are worked on by staff in any given fiscal year. Projects that have future funding identified, but are not funded in the current year, are in a "holding pattern" until funding can be identified and linked to that project. If there are no designated funds for a particular CIP, then no work is done on that CIP.

Some CIPs are funded over several years, where the first year may be the planning and design phase and the second year may be construction. Some projects show annual funding to a multi-year program.

# **DISCUSSION**

The following is the outline of the annual CIP process:

- 1. Update and prepare CIP submittals for the 2017-2019 CIP Budget including:
  - a. Update scope, project description, timelines and projected costs of current approved and proposed CIPs.
    - i. Review previously submitted CIPs for future years and either 1) assess feasibility and need for moving project into upcoming year, 2) remove from CIP, or 3) change scope of project.
- 2. Solicit new CIP projects from staff and the Commission.
  - a. Write description of project
  - b. Identify funding source
  - c. Identify phasing if applicable over multi-years of appropriation (i.e., Year 1: Planning and Design; Year 2: Construction)
- 3. Commission prioritizes all unfunded CIPs
- 4. Finalize costs. Submit to Development Services Department for review of costs, construction and soft costs.
- 5. Staff recommends CIPs to City Council

Each year, prior to beginning the CIP process for park related projects, the Parks Commission is given an opportunity to provide input. The Commission is encouraged to view the entire City CIP List, starting at section F of the current 2016-2017 budget, on the Internet at:

SENIORS By Jolene Jauregui

For the month of September there were approximately 2,893 repeat seniors that attended the Senior Center. Each week the Senior Center welcomes new participants into our programs. We had 17 new seniors visit and tour the center for the month of August.

In the month of September, the Senior Fitness programs had 910 repeat participants. A variety of fitness classes are offered Monday through Friday. Each class has very little to no impact on the body and is adaptable for every fitness level.

Throughout the month of September, the Senior Center served 573 hot lunches with an additional 20 seniors joining with their own lunches in the Multi-purpose room. In addition, Meals on Wheels delivered 820 meals to homebound seniors in Tracy. Meals are delivered every Tuesday for a 5 day supply.

Highlights for October

- Senior Tuesday continues to impact a steady group of seniors. There were 7 seniors who enjoyed Painting, Gallery Talks and special Halloween Crafts.
- The Senior Gardening Series was held on Friday, October 7. There were 19 seniors who
  decorated pumpkins using succulents.

- AARP was held on Saturday, October 10. There were 25 seniors who learned about safe driving.
- On Friday, October 14, the Senior Center held "Fun Flick Friday." There were 11 seniors who
  enjoyed watching a movie on a projection screen and free popcorn was provided. Additional
  concession items were available for purchase.
- On October 27, in partnership with the Senior Center, the University of Pacific School of Pharmacy and Health Services hosted a Health Fair for seniors and other Medicare Beneficiaries. There were 50 seniors registered that took part in numerous health screenings and testing including but not limited to; blood pressure testing, cholesterol testing, fall risk assessments and memory decline screenings. Participants were also offered a free evaluation of their Medicare Part D plan and a comprehensive review of all medications with a scheduled appointment.

### Upcoming events and programs:

- Halloween Bash: On October 31, seniors are encouraged to dress up in costumes, and dance to Halloween music and enjoy spooky Halloween treats. Prizes will be given to the best dressed participants.
- Lunch & a Movie: Seniors will enjoy a special holiday themed movie, lunch and popcorn with friends and loved ones. The event will take place on November 15 in the Grand Theatre Center for the Arts main lobby.
- Tinsel 'n Treats: On December 7, seniors will look forward to enjoying live holiday themed performances, while they indulge in sweet treats and sipping hot chocolate.
- Black & White Ball: On December 12 the Senior Center will be transformed into a Black and White "Winter Wonderland" where those in attendance will enjoy a formal sit down dinner in the company of friends. Seniors will grab their loved ones and friends and dance the night away to jazz tunes played by *In the Mood Band*.
