- Parks & Recreation Director Report Mr. Pichly wished everyone a Happy New Year and provided the following update:
 - Legacy Fields CIP going to Council soon for completion of some of the work including outfield fencing, completion of the fifth baseball diamond, restrooms, etc. Development of another list to fully amenitize Phase 1 is being drawn up.
 - Entered into an ENRA with Cal North Soccer and have had our first meeting. A number of items still need to be discussed.
 - Community Center Rehabilitation A firm is doing work to get things ready so we can put out construction bids anticipated for June this year.
 - > Senior Center Requests For Proposals went out today for an architect.
 - So. County Park Will meet with the Director of General Services at the end of the month. Plan is to make it a win-win for everyone.
 - McDonald Parks Splash Pad Engineering staff is working on a construction contract bid that won't be ready until the summer.
- Recreation Division Report Included as part of the agenda packet.
- > Community Facilities Division Report Included as part of the agenda packet.

Commissioner Jimenez noted the Community Facilities Division Report regarding rental fees earned asking if staff was working on grants or if the Commission could do anything to assist in meeting some of these program goals.

- Public Works Parks Maintenance Division Report Brian MacDonald provided the following update:
 - > Post emergent and pre-mergent spraying of the general fund parks is ongoing.
 - Tracy Sports Complex crews have been very busy with mowing and much needed field maintenance. They also have begun to renovate the infield on the north diamond at the Tracy Ball Park by removing the top eight inches of playing surface material and stock piling it. The next eight Inches of sub base material will be removed to lower the infield down to then put the top material back in so that the infield will be at turf grass level.
 - They have continued mowing the ball fields located on the west end at Legacy Fields to a lower height in preparation for spring games along with weed control in common areas and have now taken over the maintenance of the soccer fields at Legacy.
 - Equipment for the maintenance for Legacy fields has been coming in and we are in the process of hiring three new employees for the maintenance of Legacy Fields.

- Parks crews has been busy shrub pruning, small tree trimming at Civic Center along with general maintenance in all parks. Mowing in the parks has now gone into a when needed mow schedule as the turf has slowed down in growth with the colder weather.
- > Landscape Maintenance irrigation crews are continually working on irrigation.
- XL Landscape continues to move forward in getting all the parks and streetscapes mowed, edged, trash picked up and shrubs trimmed. Will be going back into the LMD Parks next week to clean up the weeds, shrubs along with broad leaf weed control in the turf, they have 18 parks left to do.
- West Coast Arborist has been grid trimming in zone three. With recent storms only five trees were lost in the City, including parks. Grid trimming the urban forest over the past couple of years has paid off.

Mr. McDonald shared a video of work being done at the Tracy Ball Park.

Commissioner Jimenez stated that the Parks Foundation did not meet in December, but will resume in January. Commissioner Jimenez added that the Foundation is requesting information (line items) amounts for projects to be broken out so they can consider funding opportunities.

REVIEW AND ACCEPTANCE OF THE PARKS AND COMMUNITY SERVICES COMMISSION'S SUBCOMMITTEE RANKING AND FUNDING RECOMMENDATIONS FOR THE ALLOCATION OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS AND HOME INVESTMENT PARTNERSHIPS PROGRAM (HOME) FUNDS FOR FISCAL YEAR 2017-2018 AND RECOMMEND APPROVAL TO CITY COUNCIL

DISCUSSION

Community Development Block Grant (CDBG) and HOME Investment Partnerships Program (HOME) funds are allocated to cities and counties by the United States Department of Housing and Urban Development (HUD) for use in projects that make for a viable community, with local programs and services that provide decent housing, a suitable living environment, and expand economic opportunities for low and moderate income individuals and families. The City of Tracy receives an annual pass-through allocation from San Joaquin County, which serves as the entitlement community. There is no impact to the City General Fund.

On November 15, 2016, the City Council adopted the Parks and Community Services recommendation for local funding priorities, to be considered in this allocation process in priority rank order:

<u>CDBG</u>

Public Services Category:

- (1) Food Distribution Services
- (2) Homelessness Prevention, Intervention and Transitional Housing Services
- (3) Senior and Special Needs Services
- (4) Domestic Violence Services
- (5) Youth Education and Enrichment Services

Public Facilities/Improvements Category:

- (1) Public Parks and Facilities
- (2) Removal of Architectural Barriers (ADA)

<u>HOME</u>

- (1) Address issues of public safety, health and welfare;
- (2) Rehabilitate residential properties occupied by low income persons; and,
- (3) Partner to construct income restricted family and senior housing facilities.

Subcommittee Review and Recommendation:

CDBG/HOME grant applications for FY 2017-2018 were available beginning December 15, 2016, with a submittal deadline of January 17, 2017. The Parks and Community Services Commission Subcommittee conducted a Special Meeting on January 23, 2017, to review and consider grant application funding requests, rank applications based on local funding priorities, and recommend funding allocation amounts to the full Parks and Community Services Commission and the City Council.

Applicants and the Parks and Community Services Subcommittee were made aware of required changes to the CDBG/HOME allocation process for FY 2017-2018. Changes include city allocation minimums per awardee of \$5,000 for CDBG Public Services and \$150,000 for CDBG Public Improvements/Public Facilities, in addition to the ranking of applications among each eligible CDBG/HOME local funding category. Ranking of applications among each local funding category will allow San Joaquin County, as the entitlement community, to potentially allocate any supplemental CDBG/HOME program funds to those highest local priority services and projects. San Joaquin County is expected to review and consider all local funded projects by May 2017.

The Parks and Community Services Commission Subcommittee made recommendations for application ranking and grant funding allocations for FY 2017-2018 as listed in Attachment A. Since the Special Meeting of January 23, 2017, the City has more fully explored available CDBG funding and is recommending an additional allocation of \$14,126 in the CDBG Public Improvements/Public Facilities category to the highest ranked project, Lolly Hansen Senior Center Expansion, increasing the recommended award from \$150,000 to \$164,126. This additional funding is not eligible for use in CDBG Public Services. All CDBG/HOME program funding is subject to final confirmation by San Joaquin County and HUD.

RECOMMENDATION

Staff recommends the Parks and Community Services Commission accept the Subcommittee's recommendations for priority ranking and funding of CDBG and HOME grant applications for FY 2017-2018 and recommend approval to the City Council.

- "Feel Better with Food" class was held on January 11th with 4 seniors in attendance. The class educates seniors on what is healthy to eat and how food affects the body.
