Brian MacDonald, Parks & Recreation Director provided a verbal report. Commission comments and questions followed.

iii. Aquatics, Athletics, and Community Facilities Division Report

Brian MacDonald, Parks & Recreation Director asked if there was anything specifically that Commissioner Lieberg would like clarification on. Commissioner Lieberg stated there was not.

iv. Public Works Parks Maintenance Division Report

Todd Rocha, Superintendent of Parks, Sports Fields and Urban Forestry provided a verbal report. Commission comments and questions followed.

Alice English asked if an item pulled from the consent calendar is open for public comment. Assistant City Attorney stated that the public is able to comment on any item on the agenda.

Commissioner Magaña and Chair Levoit asked if staff will be marketing the Veterans Park brick project. Parks Director MacDonald informed the commission that staff will continue the discussion and he will return with more information.

ACTION:

Motion was made by Commissioner Miller and seconded by Commissioner Eder to accept the Report from Parks Director, the Aquatics, Athletics, and Commission Facilities Division Report, and the Public Works Parks Maintenance Report. Roll call vote found all in favor; passed and so ordered.

### 5. REGULAR ITEMS

a. Review and Accept the Parks and Community Services Commission's Subcommittee Ranking and Recommend Funding Allocations for the Community Development Block Grant (CDBG) Funds and HOME Investment Partnership Program Funds for the 2018/19 Fiscal Year for City Council Approval

Parks Director MacDonald clarified the intent of the agenda item was to review the Parks and Community Services Commission Subcommittee's ranking and not to rerank the applicants, then recommend funding allocations for the Community Development Block Grant (CDBG) Funds and Home Investment Partnership Program Funds for the 2018/19 Fiscal Year to the City Council for approval.

Shelley Burcham, Economic Development Manager, provided the report. Barbara Harb, Economic Development Management Analyst, provided the presentation. Commission comments and questions followed. Commission asked to hear from the applicants.

Cindy Gustafson, representing Tracy Senior Association, described the services her organization provides and stated she attended the Special Meeting of the Parks Commission CDBG Subcommittee. Ms. Gustafson further expressed her disappointment with the handling of the agenda item and asked Commission to reconsider the funding allocation formula they select.

Darlene, Tracy Interfaith Ministries, stated she works with every organization and that the funding is very much needed by all the organizations and would not like to impede any organization from receiving funding. Chair Levoit stated that the funds available for allocation are insufficient to award all applicants.

Bill Fields, Surtec, described the objective of his organization. He further stated that 100% of the funding goes to the program recipients.

Alice English stated that she also attended the Parks Commission CDBG Subcommittee meeting and recommended the Commission reconsider the ranking given to the Tracy Senior Association.

Michelle Rosato, representing DRAIL, described the services provided by her organization and requested that the Commission consider the sustainability of the programs if they do not receive grant funding when allocating funding and further requested the Parks Commission CDBG Subcommittee provide the applicants with feedback on their applications.

Jennifer Rowl, Tracy Community Connections Center, thanked staff for their efforts in preparing sample funding allocation formulas. She expressed her confusion from the Parks Commission CDBG Subcommittee meeting due to her feeling that there was a lack of clarity on the purpose of the meeting.

Commission comments and questions followed.

Brian MacDonald, Parks Director, stated that for the FY19/20 CDBG grant review process, Commission will decide on a funding allocation formula at the Parks Commission meeting when the subcommittee is appointed.

Commissioner Miller wished to express his feelings regarding the HOME Program applicant Project titled "Tracy Homes" submitted by the Housing Authority County of San Joaquin for the record.

### **ACTION:**

Motion was made by Commissioner Miller and seconded by Commissioner Eder to accept the Parks & Community Services Commission Subcommittee Ranking and Recommend Funding Allocations using example "A" as presented by staff for the Community Development Block Grant (CDBG) Funds for the Public Service category for the 2018/19 Fiscal Year for City Council Approval with the proviso that if sufficient funds are received from the county in excess of the estimated amount that the Tracy Senior Association be awarded the minimum allocation. Roll call vote found all in favor; passed and so ordered.

Motion was made by Commissioner Eder and seconded by Commissioner Lieberg to accept the Parks & Community Services Commission Subcommittee's Recommended Funding Allocations for the Community Development Block Grant (CDBG) Funds for the Public Improvements / Public Facilities category for the 2018/19 Fiscal Year. Roll call vote found all in favor; passed and so ordered.

Motion was made by Commissioner Miller and seconded by Vice Chair Jimenez to accept the Parks & Community Services Commission Subcommittee Ranking and Funding Allocations for the HOME Investment Partnership Program Funds in the amount of \$54,000 for Eden Housing, Inc. for the 2018/19 Fiscal Year. Roll call vote found all in favor; passed and so ordered.

Motion was made by Commissioner Eder and seconded by Commissioner Lieberg to accept the Parks & Community Services Commission Subcommittee Ranking and Funding Allocations for the HOME Investment Partnership Program Funds in the amount of \$58,000 for Housing Authority County of San Joaquin Inc. for the 2018/19 Fiscal Year. Roll call vote found all in favor; passed and so ordered.

### 6. COMMISSIONER COMMENTS

- Commissioner Miller commended staff on making the project a more quantitative process.
- Commissioner Eder expressed she is happy to be a part of the vibrant Tracy Community.
- Vice Chair Jimenez was not able to provide an update from the Tracy Friends for Parks, Recreation and Community Services Foundation as she was unable to attend last month's meeting due to scheduling conflicts. She stated that she submitted the Parks Commission Report to the Foundation for their records. Vice Chair Jimenez asked staff to submit to her any funding needs for volunteer projects that she can return to the TFFPRCSF for their review. She further thanked staff for their assistance with the grant funding allocation process.

### **DISCUSSION**

At the Regular Meeting of the Parks and Community Services Commission on October 5, 2017 the Commission approved the Commission Goals and Objectives for Fiscal Year 2017/2018 (Attachment B). Since then, four new Parks Commissioners were appointed.

In the past, the Parks and Community Services Commission have set annual goals that were used to focus their activities for the year. These goals provide a road map for the Commission to meet the needs and seek input from the community and to align their actions within the purview of the Commission.

It is important for the commission to consider their goals in the context of the commission's purpose and roles and responsibilities as outlined in the Parks Commission bylaws. As the commission considers their potential goals, consideration should be given to the following items:

- 1. Does the goal tie in to the Parks Commission purposes or roles and responsibilities?
- 2. Does the goal fit the S.M.A.R.T. pattern? (Specific, Measurable, Attainable, Relevant, Timely)
- 3. What will be the outcome for each goal?
- 4. How are we ensuring that there is community involvement?

Additionally, when creating a new plan for the commission, it is important to know the difference between a goal and an objective. A goal establishes where you want to go or what you want to do. An objective is a specific step that is needed in order to reach your goal. Goals are generally broader in nature while an objective will be more specific and will have a timeline and action steps associated with it.

Staff would like the Commission to review the purpose, roles and responsibilities of the Parks and Community Services Commission (Attachment A) and your past goals (Attachment B), and give the newly appointed Commissioners an opportunity to provide input. We will then bring back for your approval, at a later meeting, any revisions made to your goals and objectives for fiscal year 2017/2018.

### **ATTACHMENT A**

## PURPOSE, ROLES AND RESPONSIBILITIES OF THE PARKS AND COMMUNITY SERVICES COMMISSION

### A. PURPOSE

The purpose of the Parks and Community Services Commission is to:

- 1. Establish rules and regulations governing the conduct of recreation programs, protection of property and activities of persons in all parks.
- 2. Establish rates, charges and deposits for the use of any and all recreation facilities.
- Hold public hearings on recreation programming and facility usage and conduct investigations and surveys for the purpose of obtaining facts and data concerning recreation programs.
- 4. Review grants, facility developments and designs and recreation programs.
- 5. Advise the Council on the subject of recreation and facility master planning and development.
- 6. Make recommendations to the Council regarding the right to exclude persons; to regulate traffic, including pedestrian, equestrian, and vehicular; and to regulate the operations and use of bicycles; the keeping or use of animals; the conducting of assemblies, contests, games, and sports; and the regulation of activities, such as the merchandising, advertising, gambling, solicitation, and imbibing of alcohol, from or in any and all recreation facilities.
- 7. Forward appeals of any actions of the Commission to the Council.
- 8. Hear appeals of decisions made by the Parks and Community Services Department Director under TMC 4.40.150 (Special Event Permits).
- 9. Hear appeals of park permits issued or denied by the Parks and Community Services Department Director under TMC 4.16.160 (Regulations Pertaining to the Use of Park and Recreation Areas and Facilities).

### B. ROLE AND RESPONSIBILITIES

The role of the Parks and Community Services Commission is to provide citizen and community perspective and input on the development of park and recreation facilities and the delivery of recreation and community service programs.

SENIORS By Jolene Jauregui

For the month of January there were approximately 3,059 repeat seniors that attended the Senior Center. Each week the Senior Center welcomes new participants into our programs. We had 34 new seniors visit and tour the center for the month of January.

During the month of January, the Senior Fitness programs had 1,195 repeat participants. A variety of fitness classes are offered Monday thru Friday. Each class has very little to no impact on the body and is adaptable for every fitness level. On January 10, the Senior Center introduced its new BARRE for Active Aging fitness class which focuses on strengthening muscles through mixed elements of Pilates, Yoga, Ballet and Functions Training.

Throughout the month of January, the Senior Center served 404 hot lunches with an additional 45 seniors joining with their own lunches in the Multi-purpose room. In addition, Meals on Wheels delivered meals to 41 homebound seniors in Tracy. Meals are delivered every Tuesday for a 5 day supply.

### **Highlights for February:**

- AARP Tax Assistance began on February 5. There are 70 seniors signed up for the month of February. Appointments are available on both Monday's and Tuesday's.
- On Tuesday, February 13, the senior center offered an iPhone training class in partnership with California Telephone Access Plan. There were 9 seniors that learned how control volume, send text messages, connect Bluetooth devices and much more.
- On Tuesday, February 13, the annual Lunch & a Movie was held in the lobby of the Grand Theatre
  Center for the Arts. There were 61 seniors that enjoyed a lovely lunch catered by Olive Garden,
  followed by a Valentine's Day themed movie.
- On Wednesday, February 14, a seminar covering "Fall Prevention & Balance" was presented by Visiting Angels to a group of 11 seniors. The seniors in attendance walked away with a greater knowledge of how to prevent falls and strengthen their balance.

### **Upcoming events and programs:**

- On Friday, March 16, the Senior Center will host a St. Patty's Day Luncheon. This annual event brings in a large crowd of over 100 seniors who enjoy listening to Irish music, visiting with friends and enjoying a traditional St. Patrick's Day lunch.
- On Wednesday, April 18, the Senior Center will be taking a trip to Fresno's Forestiere Underground Gardens. The site is a network of underground rooms, courtyards and passageways alive with fruit producing trees and vines.
- On Wednesday, April 26, seniors will enjoy a wonderful spring afternoon in the Senior Outdoor Recreation Area at our Spring Time in Paris event. The afternoon will be filled with activities, food and prizes. There will be a hat contest for 1st, 2nd, and 3rd place.
- Staff is preparing for Older American's Month in May. In recognition of our older adults, the Senior Center will offer a full month of presentations, events, and fun activities to celebrate the contributions of our seniors.


### A.S.P. – AFTER SCHOOL PROGRAM
