Commissioner Levoit reported that he attended the homecoming parade for Millennium High as well as he will attend West Highs and Tracy Highs. He stated it went great. Commissioner Levoit reported that Kimball no longer does a parade, but a homecoming celebration at the school.

Commissioner Levoit reported he has attended several events at Lincoln Park. Sept 16th was Mexican Independence Day, Sept 28th was the One World event hosted by the Chamber which was a nice cultural Event. October 5th will be an event with Chest of Hope.

Commissioner Levoit reported he has been reaching out with Operation Helping Hands which involves the Public Health and several nonprofit organizations that help the low income families and homeless. He has been going out and locating the homeless.
