6. PROVIDE UPDATE ON MEASURE V SALES TAX REVENUE / EXPENDITURES:

Budget Officer Hedegard presented the information. The tax revenue received in Q3 was \$2,200,944. There was a slight spike in Q2 and this is contributed to the holiday season. Revenue received remains steady with YTD at \$6,903,669, with total projected revenue at \$8,339,000.

Information provided was on a newly formatted spreadsheet. Committee discussed formatting and requested changes. Budget Officer will incorporate the suggested changes into the spreadsheet.
