PROVIDE UPDATE ON MEASURE V SALES TAX REVENUE

Budget Officer Hedegard presented information on the 3rd quarter FY 17-18 Measure V tax revenue. Revenue received was \$2,210,429 for the 3rd quarter, with a cumulative YTD total of \$4,121,938. Revenue is projected at 8 million, is on track, and may exceed projections.

No Measure V funds have been expended to date.

 OVERVIEW OF GENERAL FUND SALES TAX INFORMATION RECEIVED BY INDUSTRY

Sales tax information, excluding Measure V, was presented. There is continued growth seen in sales tax. Sales tax for the 3rd quarter was \$6,018,711, an increase of \$837,987 compared to the same quarter last fiscal year.

Committee requested this report be continued moving forward.

7. OVERVIEW OF PROPERTY TAX REVENUE

This information was requested by the Committee at the last meeting. Budget Officer Hedegard presented information on the City of Tracy property tax dollar breakdown showing that the City of Tracy is receiving \$0.1690 out of every tax dollar.
