Review the Top Goals Discussed at the July 12, 2012 Regular Meeting and Develop Measurable Objectives and Outcomes for Each of the Goals: Rod Buchanan referred to the list of Transportation Commission Goals with the Objectives and Action recommended for each goal. **a. Staff Report:** Staff informed the Commission that City is going to be submitting a grant to the FTA in the amount of \$1,296,554 to be used for Operating Assistance and Fixed Route bus replacements.

- **b. Airport Updates:** Bruce Ludeman introduced Brent Wallace, Senior Location Manager at Tracy Air Center. Tracy Air Center is the fuel service provider at the Tracy Airport. Mr. Ludeman referred to the updates listed in the Airport Improvement. Item S-14 four contractors have been selected and met with regarding the fencing, paving, slurry and painting. Thorough inspection and survey has been conducted. S-17, The FAA requested that even if it is a continuation of a project to follow FAA's guidelines and to hire an Airport Engineer for the project. Staff has evaluated the bid proposals and has scheduled meetings to select the consultant company for the project. Commission will be informed and updated after the selection. S-21, roof repair has been completed and the drawings for the FBO drainage project has been completed. RFP will be out and the project is expected to complete in few months.
- **C. Transit Updates:** Year to Date ridership was at 109,563 up 6,238 riders compared to Year to date ridership in June of FY10-11, an increase of approximately 9.65%.
