3. ITEMS FROM THE AUDIENCE: Cindy Gustafson, Tracy Senior Advocacy Association, informed the Commission regarding the Sutter Hospital's Community Health Fair on Saturday, September 28, 2013. - 5. PRESENTATION ON PLANNING ASPECTS OF BIKEWAYS IN TRACY: Staff requested this item to be moved to the next month's meeting due to the presenter being unable to attend.
- 6. CORRESPONDENCE: Ed Lovell announced the hiring of the new Public Works Director Mr. David Ferguson. He is currently Assistant Public Works Director for the City of Oakland and has been in public works management since 1988 between the cities of Hayward and Oakland, and has nearly 30 years overall experience. Interim Public Work's Director Mr. Rod Buchanan has accepted the Director position for the Parks and Recreation Department in Gilbert, Arizona.

7. NEW BUSINESS:

a. Receive and Discuss Information on Transportation for County Residents: Ed Lovell went over the information discussed in the staff report. Diane Narez, of Tracy Volunteer Caregivers, addressed her concern on behalf of the county area seniors, regarding the TRACER Paratransit bus service discontinuing service to outlying county areas around Tracy. She requested that Commission look into this matter to resolve the issue and continue service to the county senior residents. Cindy Gustafson, Tracy Senior Advocacy Association, also addressed the same concerns and thanked Commission for the opportunity to address their concerns. Commission thanked the public for expressing their concerns. Commission and Staff discussed about the current service that is provided to the county residents by RTD. Commissioner Frankel stated that although this is a concern, the

area which is being discussed is outside of the purview of the commission since it resides outside of the Tracy city limits.
