PROVIDE UPDATE ON MEASURE V SALES TAX REVENUE / EXPENDITURES:

Budget Officer Hedegard presented the 3rd quarter 2019 revenue information. Revenue is presented a quarter behind to provide the time to receive the current real time revenue data.

- Revenue received for the 3rd quarter \$2,450,596
- Year-to-date \$8,349,395
- Cumulative (since Measure V began) \$19,283,030
- Natural falloff of revenue from Q2 to Q3 due to holiday sales included in the Q2.
- Overall, revenue continues to increase.
- FY projection 10 million

Actual current expenses for the 4th quarter 2019:

- Senior Center \$95,144 (Completed)
- Legacy Fields \$1,928,473
- Aquatic Center \$ -0- (Developer contribution drawn down first before Measure V funding)
- Multigenerational Facility \$ -0- (No activity until future Council discussion)
- Other \$37,924 (personnel cost)

Reviewed expense spreadsheet that displays by project the funds expended to vendors during the reporting period. Committee requested that an appropriate description (Internal Charges) be added to the line items that are currently blank and to add a title to the spreadsheet.

# 7. DISCUSS MEASURE V ANNUAL REPORT TO COUNCIL:

Chairperson Bazinet provided information to the committee members on how past annual reports were presented to the Council. Last year the report was provided as an informal presentation prior to the start of the Council meeting.

Chairperson Bazinet discussed a spreadsheet that he developed that may possibly be used in the presentation to Council. After a lengthy discussion, the committee agreed that the spreadsheet that Budget Officer Hedegard prepares will be used, along with a Power Point Presentation showing the annual highlights. Committee Member Wahid volunteered to present the presentation to Council.

Committee discussed having a special meeting on October 7, 2019. This meeting will provide the Committee an opportunity to review and make changes to the report and Power Point. At the regular meeting on October 21, 2019, the annual report will be approved.

The annual report will be presented to Council at the November 19th Council Meeting.
