- **6. CORRESPONDENCE:** Ed Lovell introduced newly appointed Commissioners Noel Varela and Larry Gamino. New Commissioners provided a brief introduction to the Commission.

7. OLD BUSINESS:

a. Review and Provide Input on Commission Goals and Objectives:

- 1.1 Staff recommended revisiting the goals and objectives. Transportation Fair Subcommittee will provide updates at the next TAC meeting. Commissioner Carter informed no airport events are planned at this moment. Audience suggested holding an airport event during the reopening of the newly paved runway. Commissioner Silva provided ideas for bicycle events. Staff recommended the Bike to Work Event be in conjunction with the Annual Safety Fair by the City Police Dept., with the next event held in May 2016.
- **2.1** Staff informed Commission on securing an FTA grant to update the Short Range Transit Plan.
- 2.2 Commissioner Carter informed the airport survey questionnaire is ready to be posted at the airport and other locations. Commissioner Vaughn suggested holding a TAC meeting at the airport to show the new commissioners the airport. Richard Ortenheim, Skyview Aviation, recommended that the Commission visit the airport. He also provided information regarding his business at the airport.
- 2.3 Commissioner Silva mentioned he is waiting for a respond from the City on the request submitted regarding bike path study. Commissioner Krogh requested how often the

PROVIDE INPUT ON COMMISSION GOALS AND OBJECTIVES FOR FY 2015/16 AND FY 2016/17

DISCUSSION

At the February 13, 2014 regular Transportation Advisory Commission (TAC) meeting, the commission held discussion on goals for the commission to work on over the next two of years. The goals suggested by the commission at that time are as follows:

- Transportation Fair
- Sponsor/support airport activity
- Sponsor/support bicycle activity
- Commission education
- Review of Bylaws
- Identify ways to increase airport revenue
- Review transit routes
- Annual review of current planning docs (AMP, BMP, SRTP)
- Address senior related issues
- Conduct airport survey

These goals were ultimately realigned into two main goals of Community Outreach and Commission Education. A draft of potential key focus areas, objectives, actions steps, timelines and assignments was presented and approved during the regular meeting for each of the Commission developed goals on March 13, 2014.

Since the February 13, 2014 meeting, there have been a number of new commissioners who have joined the commission. Additionally, as we are approaching the end of the City's FY 2014/2015, it is an appropriate time to revisit the goals and establish goals and objectives for the next two fiscal years with input from the new commissioners.

Staff feels that it is important for the commission to consider their goals and objectives in the context of the commission's purpose and roles and responsibilities as outlined in the TAC bylaws. As the commission considers their potential goals and objectives, consideration should be given to the following items:

- What will be the outcome for each goal?
- Does the goal tie in to the TAC purposes or roles and responsibilities?
- How are we ensuring that there is community involvement?
- Does the goal fit the S.M.A.R.T. pattern? (Specific, Measurable, Attainable, Relevant, Timely)

Additionally, when creating a new plan for the commission, it is also important to know the difference between a goal and an objective. A goal establishes where you want to go or what you want to do. An objective is a specific step that is needed in order to reach your goal. Goals are generally broader in nature while an objective will be more specific and will have a specific timeline attached to it.

Staff is asking the commission to review the purpose and roles and responsibilities of the TAC (listed below) and come prepared to share ideas and discuss future goals for the commission.

FISCAL IMPACT

There is no fiscal impact to the General Fund, Transportation Fund or Airport Fund for this item at this time.

RECOMENDATION

ATTACHMENT A

PURPOSE, ROLES AND RESPONSIBILITIES OF THE TRANSPORTATION ADVISORY COMMISSION

A. PURPOSE

The purpose of the nine-member Transportation Advisory Commission is to:

- 1. Address various public transportation issues including intra-city transit (TRACER, Paratransit, airports, Multimodal Station, taxis, limousines, Park-and-Ride lots, bikeways, trails and passes) and inter-city transit (SJRTD, commuter-vanpools and ACE):
- 2. Review City-wide public transportation and airport planning documents;
- 3. Advise on service levels and routes:
- 4. Recommend rules and procedures governing public transportation service programs, equipment and facilities considering regulatory guidelines, service improvements, coordination, efficiencies, protection of property, service improvements and activities of persons utilizing transportation services and facilities;
- Recommend rates, fares, user fees, charges and deposits for the use of transportation service programs and facilities;
- 6. Review surveys and facilitate public input on public transportation programming and facility usage;
- 7. Identify transportation infrastructure needs and recommend allocation of funds for capital expenditures related to transportation improvements;
- 8. Review grants, budgets, facility developments and designs, and transportation programs;
- 9. Advise the Council on the subject of comprehensive Citywide public transportation master planning and development;
- 10. Review, monitor, and make long-range recommendations concerning public transportation and connectivity sections of related environmental impact reports of development projects during the public review period and other similar documents;
- Recommend and promote marketing strategies for community outreach programs in order to strengthen the transportation image, increase usage, and integrate its role within the community; and
- 12. Recommend to the City Council, after public input, the adoption, amendment or repeal of ordinances, resolutions, or requirements pertaining to public transportation within the City.

B. ROLE AND RESPONSIBILITIES

The role of the Transportation Advisory Commission is to provide citizen and community perspective and input on the development of public transportation planning, facilities and programs. As a Commission established by the City Council, the Transportation Advisory Commission will provide input to Council for their consideration and action. This would ideally be done after receiving public deliberation and achieving consensus through partnering with staff. It is intended that the Transportation Advisory Commission not take an advocacy role, but an advisory role, in providing input to City Council. Additionally, the Transportation Advisory Commission is expected to advise City Council on transportation matters brought to them by the community.
