REQUEST

APPOINTMENT OF A SUBCOMMITTEE FOR PARTICIPATION IN AIRPORT RULES AND REGULATIONS REVIEW

DISCUSSION

The current approved Airport Rules and Regulations are listed in the Tracy Municipal Code section 2.28. This code is outdated and staff is recommending that the existing ordinance in its entirety be replaced with a new ordinance detailing the airport's new rules and regulations.

Staff is requesting two Transportation Advisory Commissioners to participate in the review of the recommended ordinance changes. The adoption of this new ordinance by City Council would implement new rules and regulations at the Tracy Municipal Airport. Subcommittee members will receive a copy of the recommended ordinance by no later than August 20, 2015. Recommendations will need to be submitted to staff by no later than September 2, 2015. The subcommittee will present their recommendations at the regular meeting of the Transportation Advisory Commission on September 10, 2015. It is anticipated that the proposed ordinance will be taken to City Council for approval at their October 6, 2015 regular meeting.

RECOMMENDED ACTION

That the Commission Chair appoint a two-person subcommittee for participation in Airport Rules and Regulations review.
