6. PROVIDE UPDATE ON MEASURE V SALES TAX REVENUE / EXPENDITURES AND REVIEW CHANGES TO THE REVENUE & COMMITMENTS MEASURE V FUNDS REPORT.

Budget Officer Hedegard presented the Q1 2019 information. Revenue received for the quarter and year-to-date is \$2,831,513. Cumulative (since Measure V began) is \$13,765,148.

Actual expenses during the 1st quarter were \$2,162,006, with the largest expenditures being Legacy Fields - \$801,356, Senior Center Renovation - \$739,395 and Aquatic Center - \$532,982.

Budget Officer Hedegard presented a new expense spreadsheet that displays the project and funds expended by vendor. The spreadsheet format and information provided was discussed and some changes were requested.

7. Discussion on Providing Quarterly Measure V Updates to Council

Committee members discussed providing a quarterly update of Measure V revenue/expenditures to the City Council. The item will be on consent, one page staff report with the Revenue & Commitments Measure V Funds Report attached.

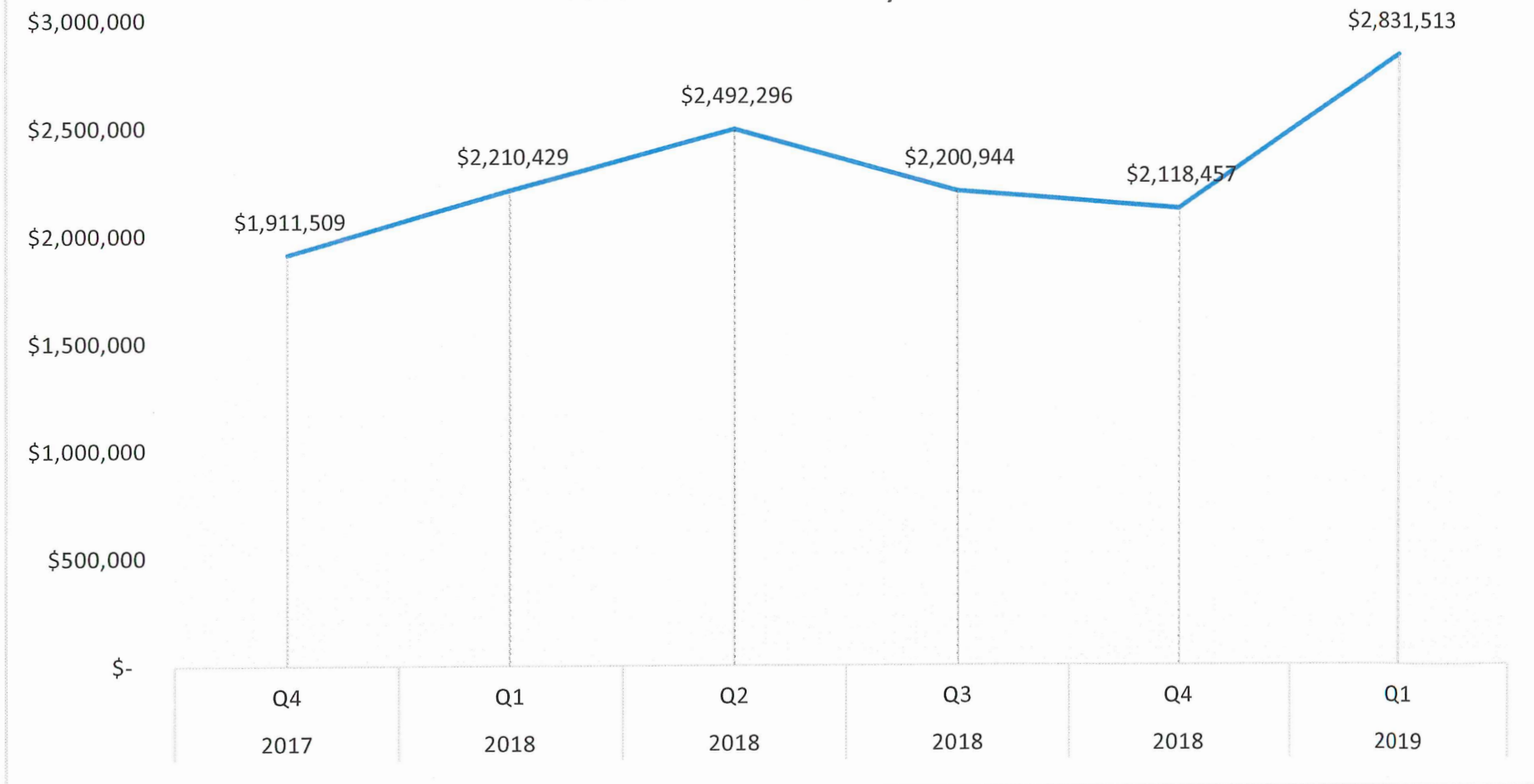
