6. REVIEW OF BYLAWS:

New committee members were provided a copy of the bylaws. Budget Officer Hedegard provided a brief overview of the committee's role and asked the new members to review the bylaws and contact him with any questions.

7. MEASURE V PROJECTS UPDATE:

Richard Joaquin, Parks Planning & Development Manager, gave a Power Point presentation on the status of projects receiving Measure V funding:

- Lolly Hansen Center upgrade – Estimated to be completed in the next month. Measure V funding \$950,000 remaining funds from CDBG.
- Legacy Fields, Phase 1C – 72 acres of recreational area, concessions, restroom, plaza areas, and shade structures. Measure V funding \$3.6 million.
- Legacy Fields, Phase 1D – Sports field lighting, security camera system, plaza areas, shade structures. Measure V funding 6.4 million.
- Future projects – Aquatic Center and Multi-generational Center will be brought to the City Council in the future to discuss priorities and further funding.

8. PROVIDE UPDATE ON MEASURE V SALES TAX REVENUE / EXPENDITURES:

Budget Officer Hedegard presented the 2<sup>nd</sup> quarter 2019 revenue information:

- Revenue received for the 2<sup>nd</sup> quarter - \$3,067,286
- Year-to-date - \$5,898,799
- Cumulative (since Measure V began) - \$16,832,434
- Revenue continues to increase each quarter

Actual expenses for the 3<sup>rd</sup> quarter 2019:

- Legacy Fields - \$101,981
- Aquatic Center – 91,161
- Multigenerational Facility - \$5,711
- Other - \$29,694 (personnel cost)

Reviewed expense spreadsheet that displays by project the funds expended to vendors during the reporting period.

Chairman Bazinet requested that an item be placed on the next agenda for the committee to discuss the formatting of the annual report that is presented to Council. Committee member Wahid supported the request.



## Background

- In late 1951, San Francisco Chronicle wrote a 10-part series on “Your Secret Government.”
- Modesto Assemblyman Ralph M. Brown carried bill that was signed into law in 1953.

## Purpose

“All meetings of the legislative body of a local agency shall be open and public, and all persons shall be permitted to attend any meeting of the legislative body of a local agency, except as otherwise provided in this chapter.”

## Legislative Body

- Governing body
- Commission or committee
  - Permanent or temporary
  - Created by action of the legislative body
- Exceptions

## Meetings

- A majority discussing, hearing, or acting on agency business
  - Note: Quorum of Measure V Committee is 3
- Serial meetings
  - Intermediaries
    - Daisy-chain
    - Hub-and-spoke
  - Technological devices (e.g. emails)

## Meetings - Exceptions

- Individual contacts
- Conferences\*
- Open community meetings\*
- Another body of the agency\*
- Social or ceremonial events\*

\* Provided that a majority of the members do not discuss among themselves, other than as part of the scheduled program, agency business.

## Meetings - Location

- All meeting locations must be accessible to the public, including the disabled
- Inside Agency's Boundaries
- Outside Agency's Boundaries
  - Exceptions

# Notice and Agenda Requirements

- Agenda must contain a brief general description of each item to be discussed or acted upon at the meeting
  - Typically does not exceed 20 words

# Notice and Agenda Requirements

- **Regular Meeting**
  - Agenda
    - Posting agenda at least 72 hours before
    - Describe on agenda each distinct action
    - Post on website
  - Public Comment
    - Not required to register name or address
    - Time limits permitted
  - Non-Agendized Matters
    - Came to agency's attention after the agenda was posted
    - Need to take action before next meeting
    - Two-thirds vote required

# Notice and Agenda Requirements

- **Special Meeting**
  - Agenda
    - Posting agenda at least 24 hours before
- **Emergency Meeting**
  - When prompt action is needed due to the actual or threatened disruption of public facilities. An “emergency situation” exists if the legislative body determines a work stoppage, crippling disaster, or other activity severely impairs public health, safety or both.

# Notice and Agenda Requirements

- Mail agenda upon written request:
  - To any person who has filed a written request for such materials.
  - A request for notice is valid for one calendar year and renewal requests must be filed January 1 of each year.

- Agenda requirements
- “Safe Harbor”
- Open session announcement
- Reportable action vs. action taken
- Who can attend – essential staff

# Penalties

- Criminal Penalties
  - Action taken
  - Violation of Brown Act
  - Intent
- Civil Penalties
  - Invalidation of action
    - “Cure and Correct”
  - Litigation and attorney’s fees
  - Disclosure of confidential information

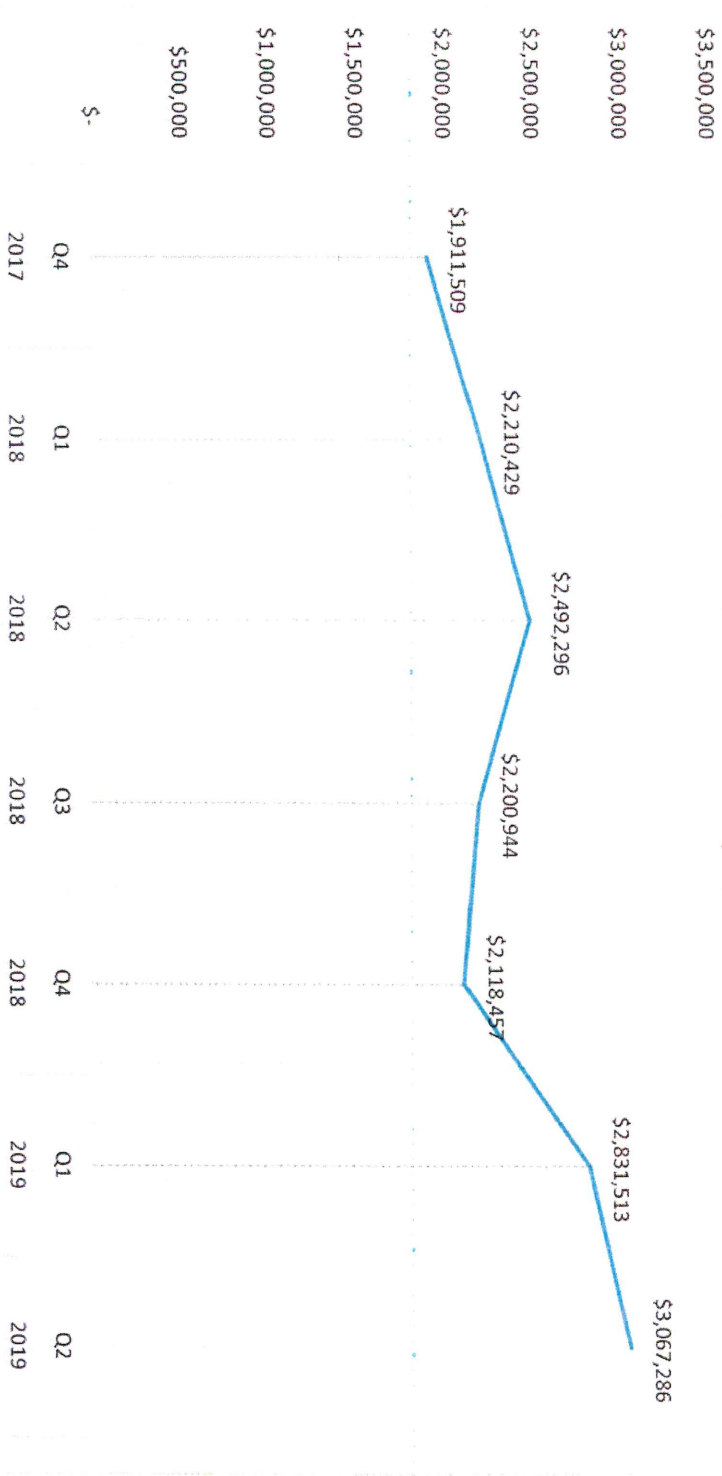
